Prior Security Interests. Leaseholds; Condominiums; Planned Unit Developments. Mortgagor agrees to comply with the provisions of any lease if this Security Instrument is on a leasehold. - 6. WARRANTY OF TITLE. - 7. DUE ON SALE.
