That the By-law and the Authorization set forth above are true copies thereof and are now in full force and effect.

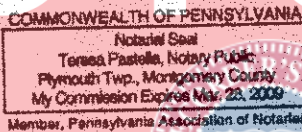
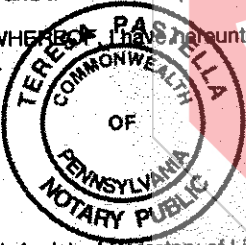

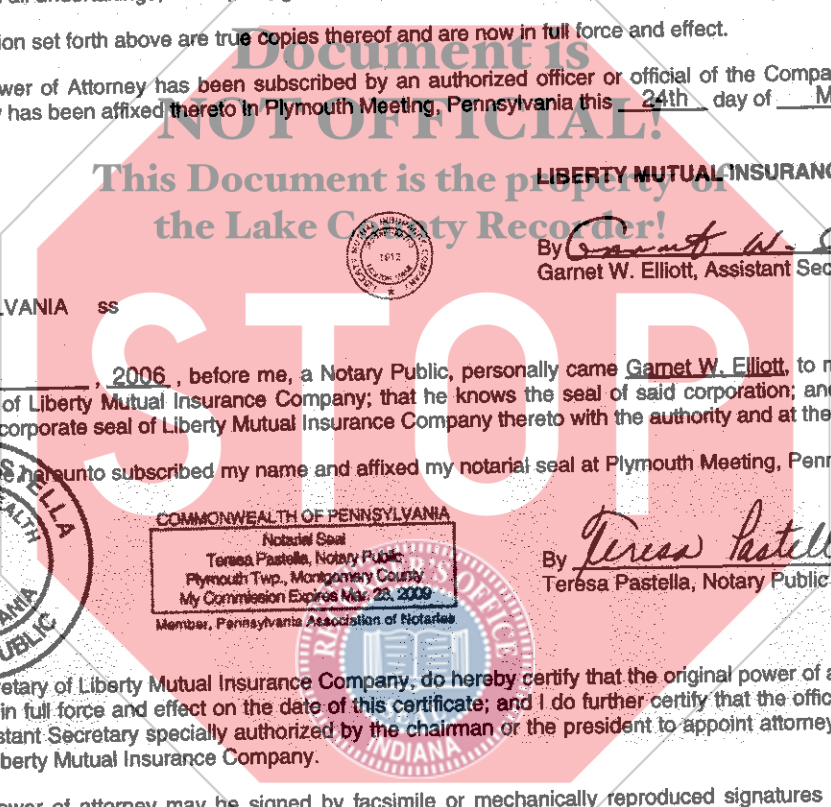
