A. Current Trustees:

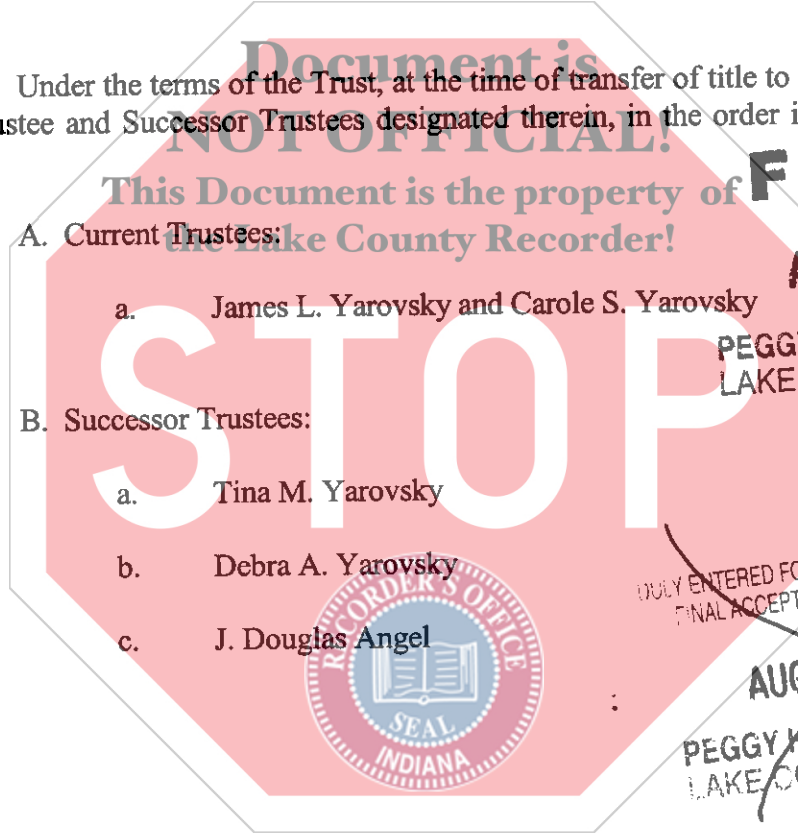
