(HOME PROGRAM LIEN)

THIS MEMORANDUM OF AGREEMENT evidences the existence of a First-Time Home Buyers Down payment Assistance Agreement (the "Agreement"), dated June 13, 2006, by and between the Property Owner, Sandra T. The Borrower agrees to maintain the Property as an owner-occupied residential property for a minimum of \_\_\_five\_\_ (5) years from the date of the completion of the project (the "Affordability Period"). The Borrower must repay the HOME funds if the property is sold, transferred, or conveyed during the Affordability Period, or if use of the property has changed. Temporary sub-leases are not allowed. Repayment of funds shall be forgiven on a pro-rated basis in the amount of 20% per year for five years.

The Agreement contains other agreements and covenants of the parties, as set 4. forth in an executed counterpart of it in possession of the parties.
