Ida Mae Link, Administratrix, appears in person. Barbara Rosenberger, heir, ey for the Estate, appears in person. appears in person. James J. Nagy, Submitted on Petition for Instructions. Court FINDS that the Administratrix has failed to pay the Indiana Inheritance Tax. The amount of said tax if paid on or before June 23, 2006, is \$855.93. The Administratrix should be ordered to pay said tax in full on or before fourteen (14) days from this date. Failure to pay said tax in full on or before fourteen (14) days from this date shall result in contempt proceedings being initiated against the Administratrix.

The Court also FINDS that the Administratrix has failed to pay the fees of Attorney James J. Nagy as ordered by this Court in its order of December 6, 2005; and that there is due and owing the amount of \$3,000.00 for said attorney fees. Judgment in the amount of \$3,000.00 should be entered for Attorney James J. Nagy against Ida Mae Link, personally. Ida Mae Link should be permitted to pay said judgment at the rate of \$100.00 per month beginning July, 2006, and each month thereafter.

IT IS, THEREFORE, ORDERED that Ida Mae Link shall pay in full the Indiana Inheritance Tax as determined by this Court in its order of February 21, 2006, within fourteen (14) days from this date.

IT IS FURTHER ORDERED that judgment is entered for Attorney James J. Nagy against Ida Mae Link personally in the amount of \$3,000.00.
