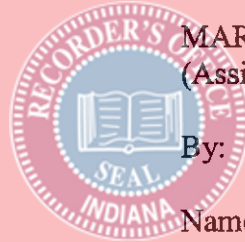

County, State of INDIANA, to-wit: All that part of the Southwest quarter of the Northeast quarter lying Northerly of Second Addition to East Gary Gardens and of East Gary Gardens Third Addition Southerly of the Burns Ditch and Northeasterly of the Michigan Central Railroad in Section 13, Township 36 North, Range 8 West of the 2nd. Principal Meridian, except the West 5 acres conveyed to Joseph C. Nicholas, in Lake County, Indiana. The pipe line shall have 30 inches of cover and shall be laid within 20 feet or less of Wolverine Pipe Line. It is hereby agreed that the stipulated terms contained herein of \$1.00 per lineal rod of Right-of-Way, are hereby cancelled, substituting in the place thereof, payment of \$10.00 per lineal rod for Right-of-Way and construction damages; payment of which shall be made in advance of construction, on receipt of which Grantee agree to execute a construction damage release. Right of Way shall not exceed fifty feet.
