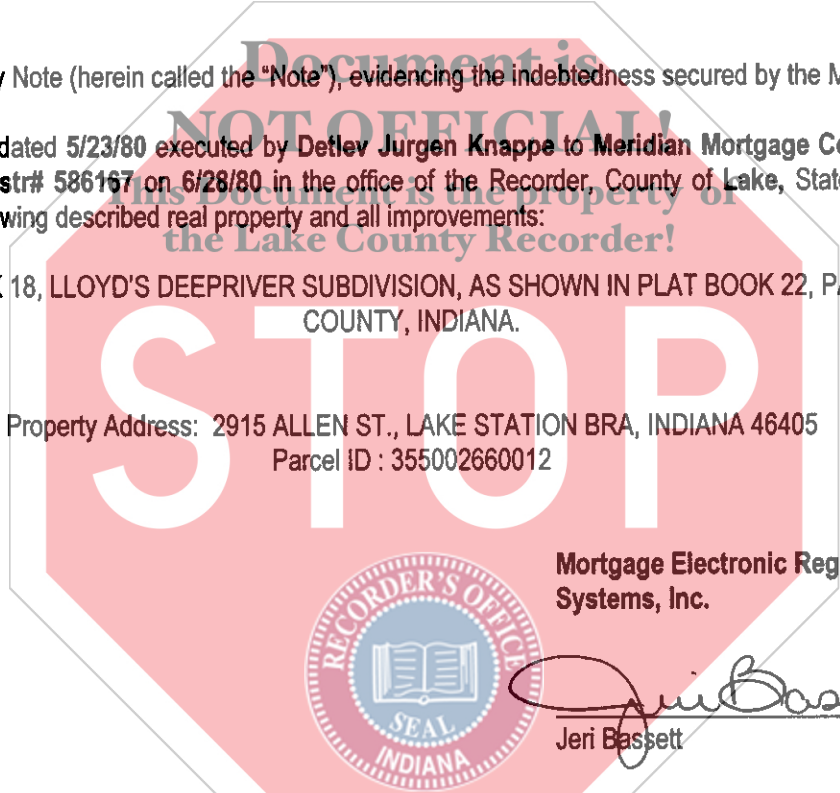
ASSIGNMENT OF MORTGAGE / DEED OF TRUST
