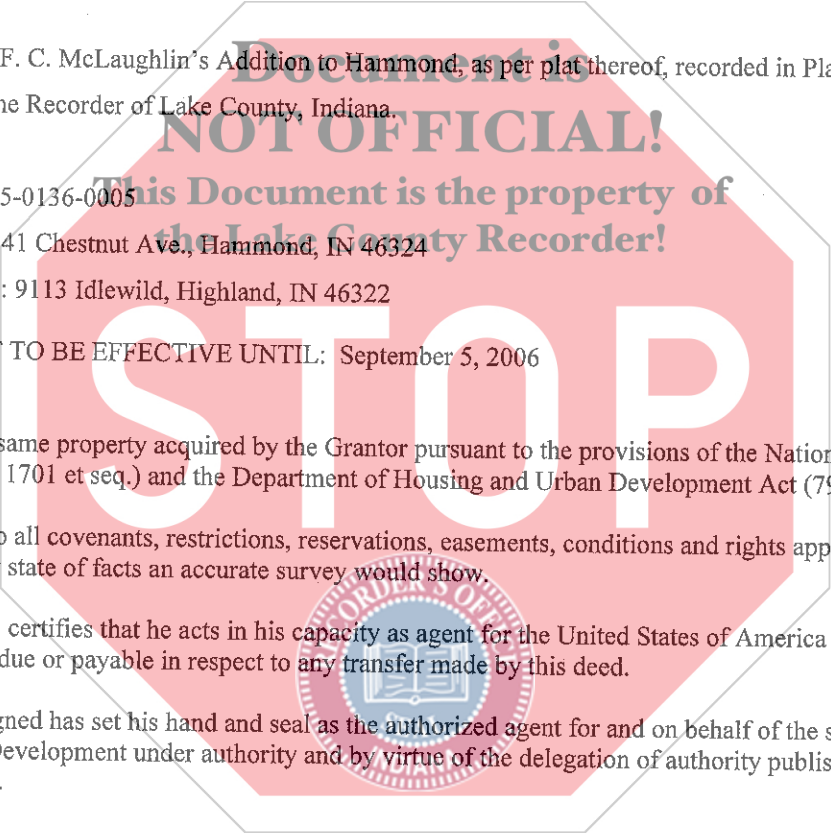
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: September 5, 2006
