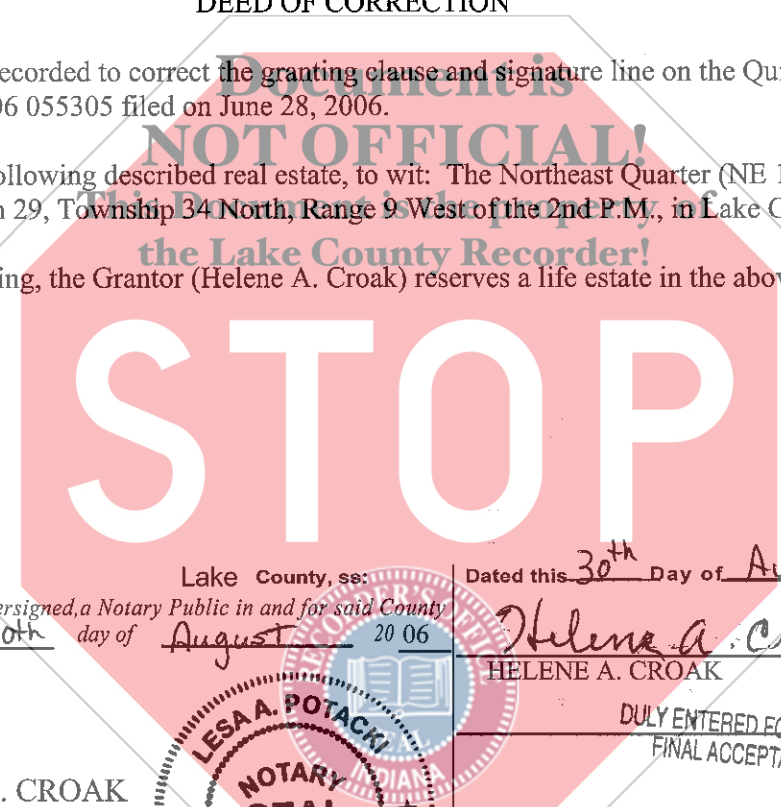

Notwithstanding the foregoing, the Grantor (Helene A. Croak) reserves a life estate in the above-described real property.



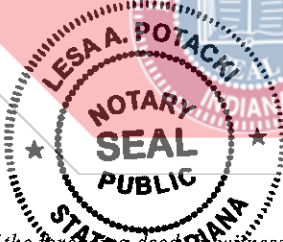
