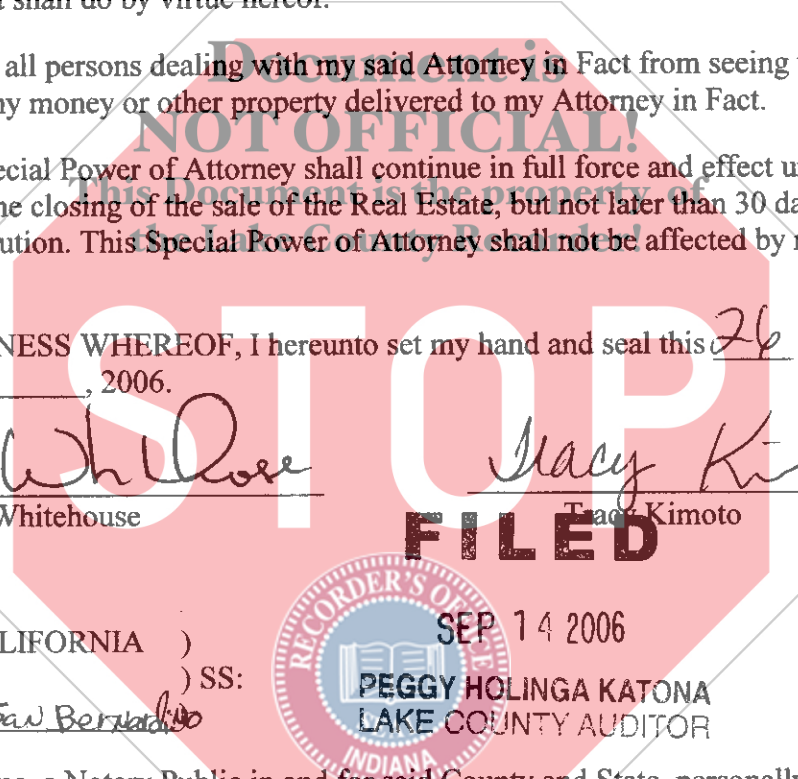
I relieve all persons dealing with my said Attorney in Fact from seeing to the application of my money or other property delivered to my Attorney in Fact.
