**GENERAL WARRANTY DEED**

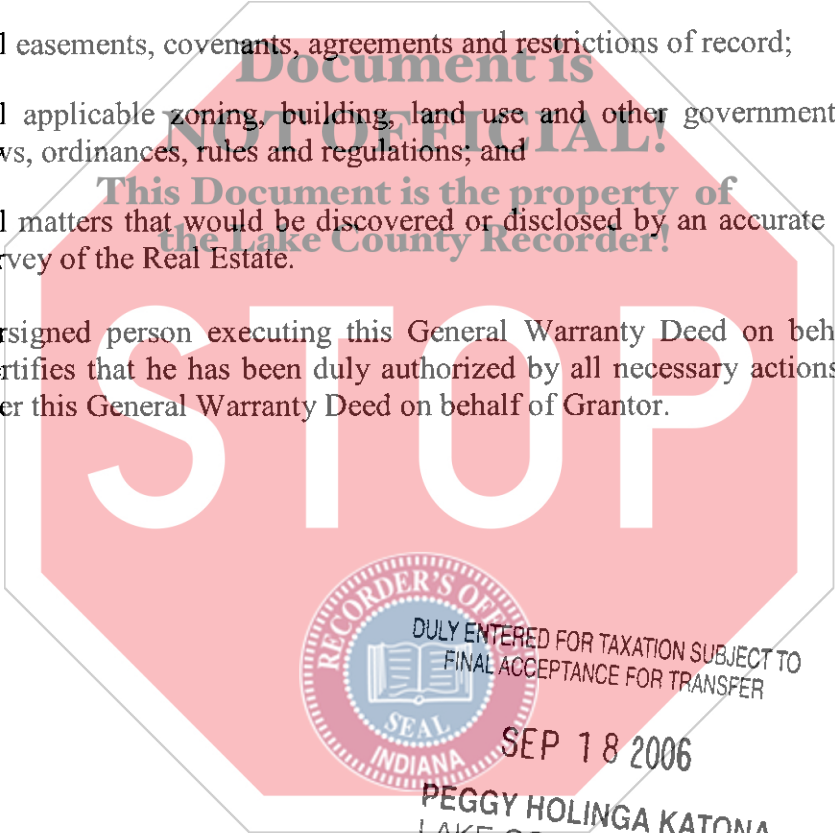

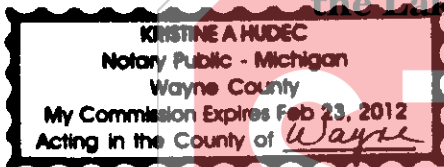

PARCEL II: Lots 17 to 23, inclusive, Lot 26, except that part thereof occupied by the railroad, and Lots 27 to 32, inclusive, in Block 11 in TOWLE and AVERY'S ADDITION to Hammond, as per plat thereof, recorded in Plat Book 1, page 104, in the Office of the Recorder of Lake County, Indiana.
