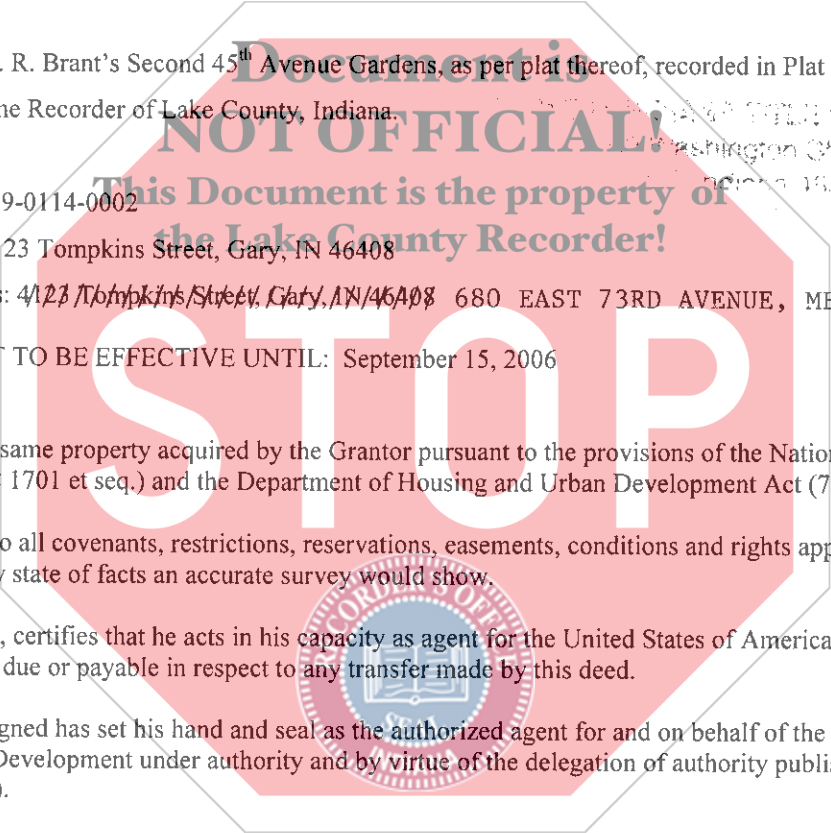
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: September 15, 2006

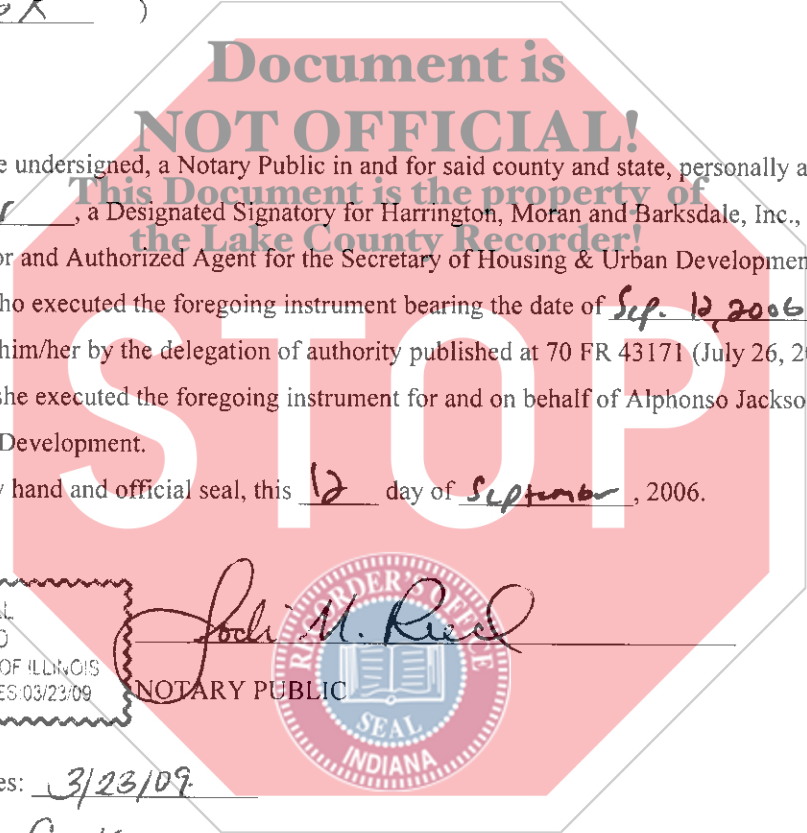
