TO: Chad Bruk

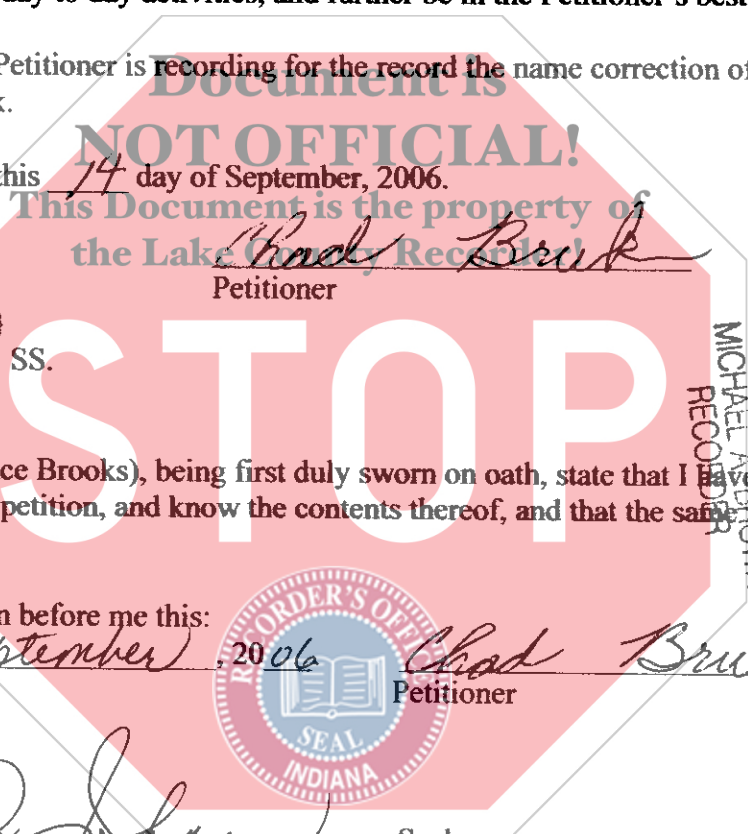
TO THE CIRCUIT COURT OF LAKE COUNTY:
