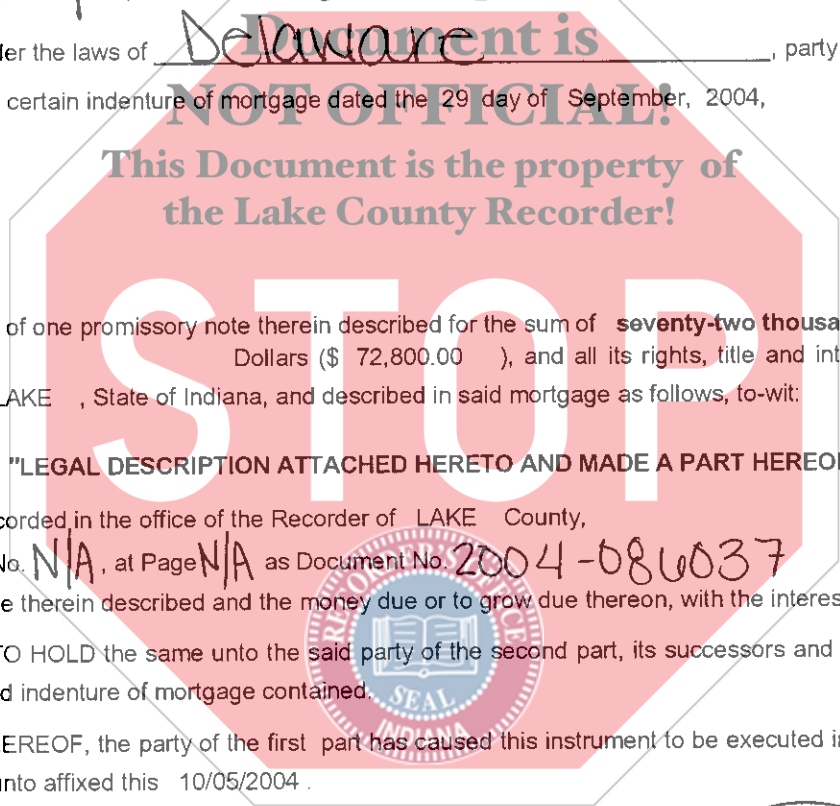
ASSIGNMENT OF MORTGAGE

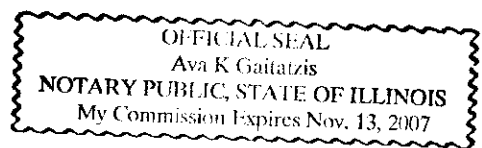
