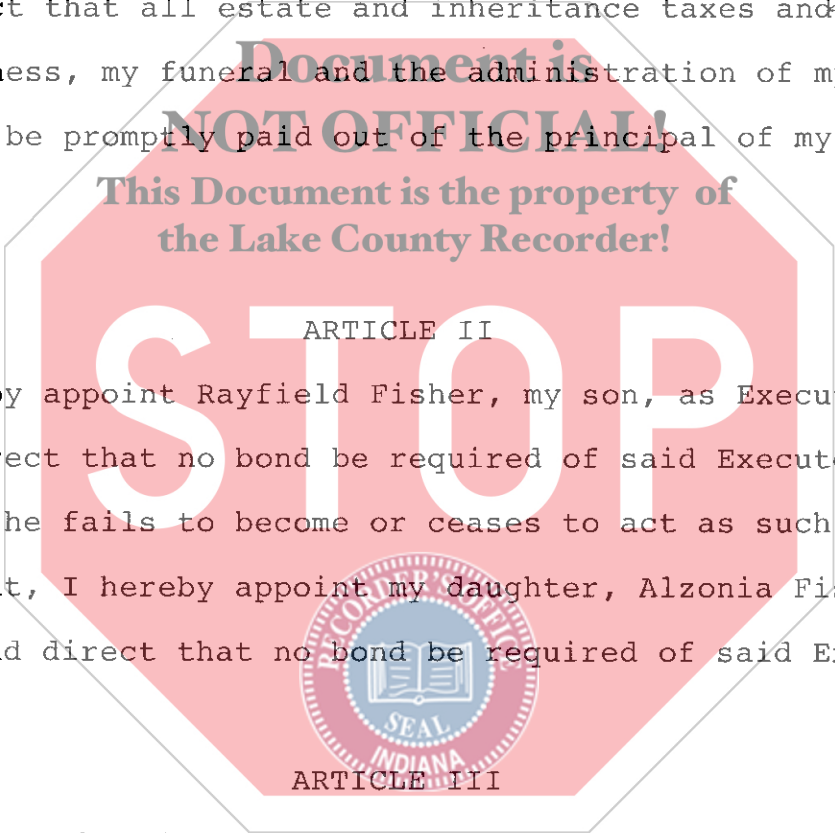

## ARTICLE II

I leave nothing to my deceased son Trammel McKenzie Fisher and his descendants. I leave nothing to my deceased son Bobby Lee Fisher and his descendants.

ARTICLE VI

In the event either Rayfield Fisher, Lloyd Buford Fisher or Lavonia Fisher Brown do not survive me, I leave their share to their descendants who survive me, per stirpes.

ARTICLE VII

In the event that my daughter Alzonia Fisher Dixon does not survive me, I leave her share to her following children, per stirpes; Sheri Capri Dixon, Kim Sharese Dixon and Dale Osbon Dixon (a one-fourth share to be divided equally between the three (3) of them).

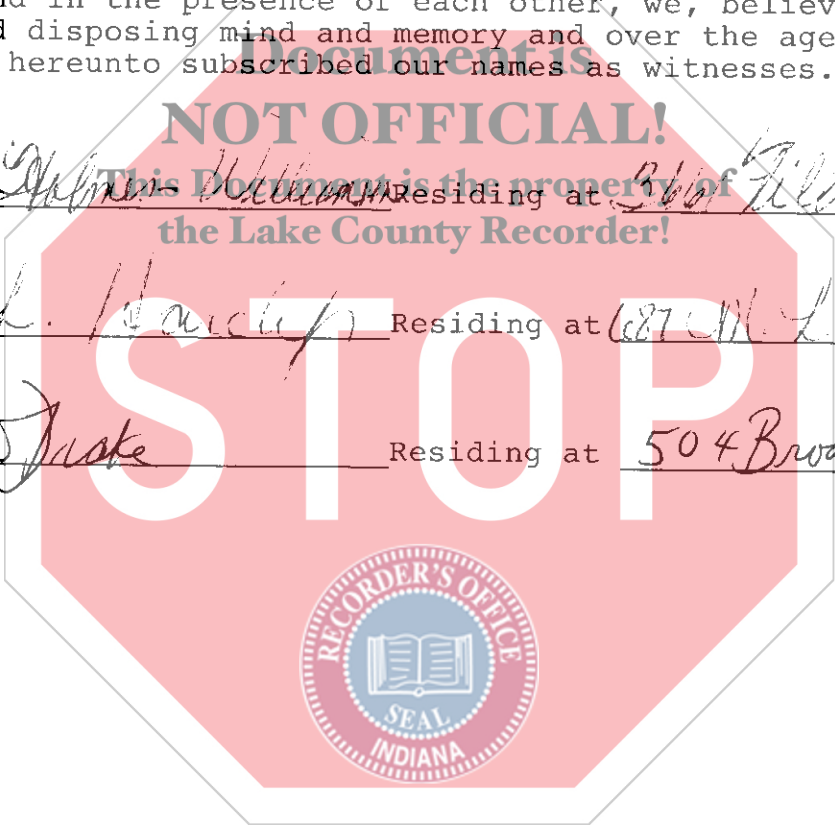
ARTICLE VIII
