Town of Dyer hereinafter called the Obligee, in the amount of Five Thousand NOT VALID FOR MORE THAN \$25,000.00

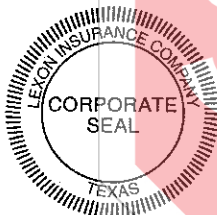

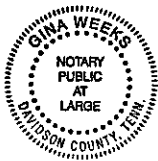
