ORDINANCE NO. 8787

AN ORDINANCE VACATING PORTIONS OF PUBLIC WAYS IN THE CITY OF HAMMOND, LAKE COUNTY, INDIANA

WHEREAS, the City of Hammond Redevelopment Commission has filed a petition requesting the vacation of public ways legally described as follows:

178th Place and Randy Drive bounded within the recorded Plat of Kennedy Park Subdivision, in the City of Hammond, as per Plat thereof, recorded in Plat Book 36, Page 21, in the Office of the Recorder of Lake County, Indiana.

WHEREAS, the Common Council of the City of Hammond, Indiana upon investigation and hearing in accordance with the law finds and determines that the proposed vacation would not hinder the growth or orderly development of the City of Hammond or the neighborhood in which the public ways are located and to which it is contiguous; and

WHEREAS, the vacation will not hinder the public's access to a church, school or other public building or place.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT it is desired and deemed necessary to vacate the said public ways which are particularly described as:

178th Place and Randy Drive bounded within the recorded Plat of Kennedy Park Subdivision, in the City of Hammond, as per Plat thereof, recorded in Plat Book 36, Page 21, in the Office of the Recorder of Lake County, Indiana.

BE IT FURTHER ORDAINED that this vacation is subject to existing utility easements.

And THEREFORE, the aforesaid right-of-way is hereby vacated.

BE IT FURTHERED ORDAINED that the Ordinance here shall have full force and effect from and after the public hearing hereon, passage and approval hereof by the Common Council, signing by the President thereof, and the approval and signing by the Mayor.

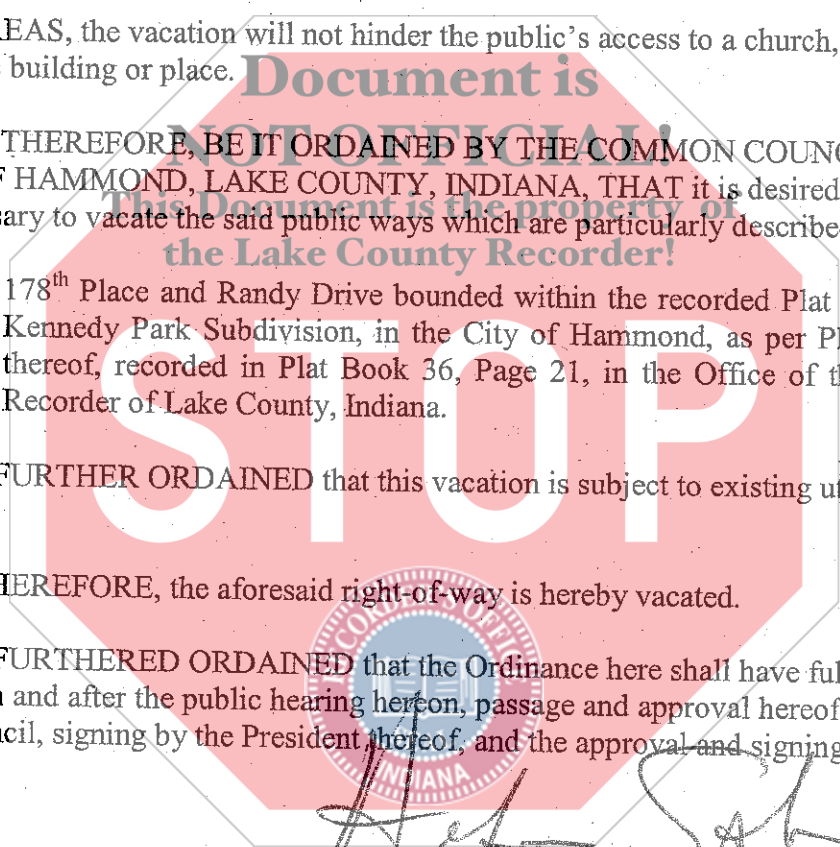
