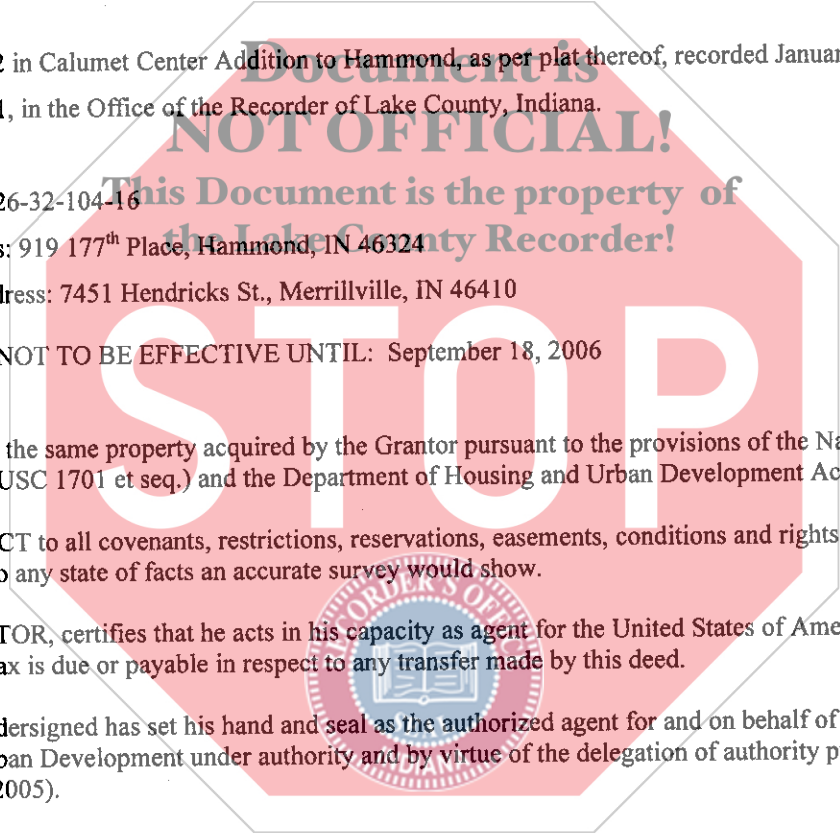
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: September 18, 2006
