AFFIDAVIT OF SURVIVORSHIP

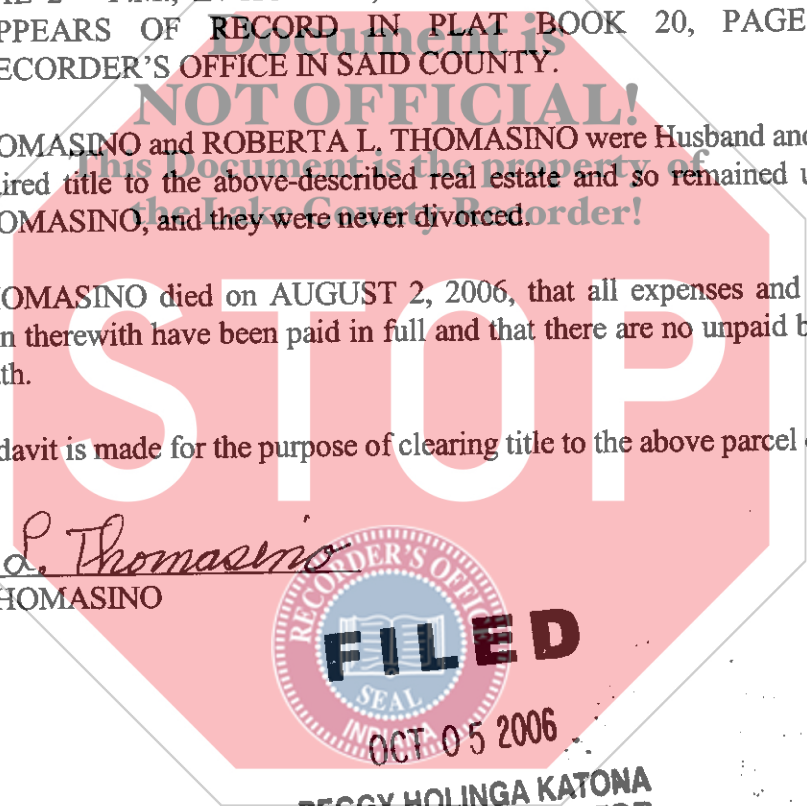
ROBERTA L. THOMASINO, being sworn upon her oath, states that:
