NOW COMES John Anthony, Malan (hereinafter "Malan") in want of counsel,
by special appearance not general appearance and of his own certain knowledge does
hereby affirm and saith as follows:

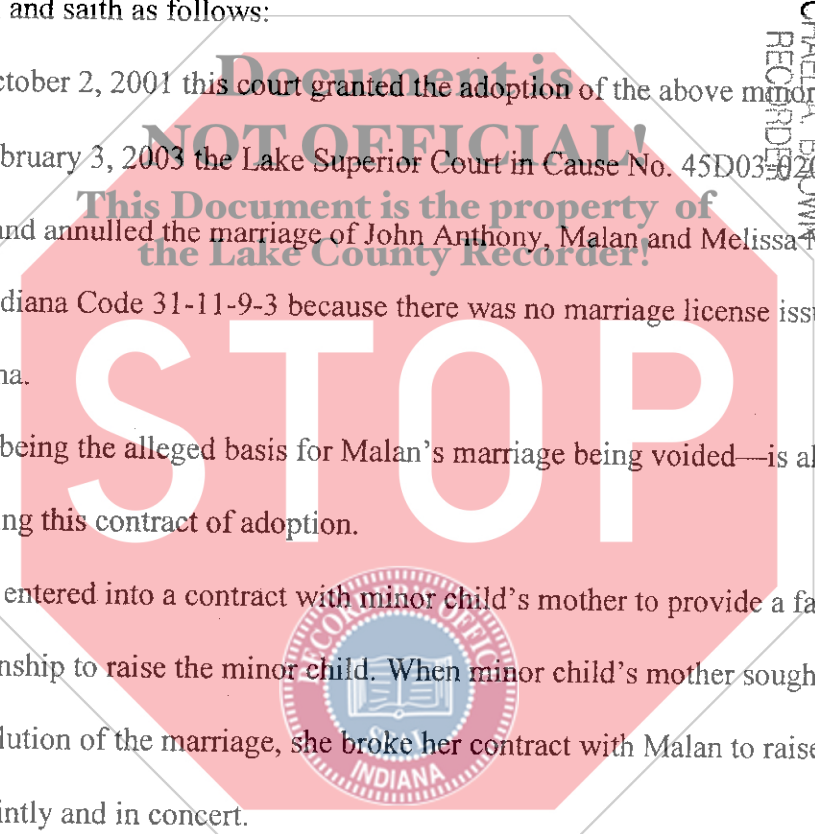
On October 2, 2001 this court granted the adoption of the above minor child

On February 3, 2003 the Lake Superior Court in Cause No. 45D03-0205-D-1504 voided and annulled the marriage of John Anthony, Malan and Melissa Mae, Malan
pursuant to Indiana Code 31-11-9-3 because there was no marriage license issued by the
State of Indiana.

Fraud being the alleged basis for Malan's marriage being voided—is also the
basis for voiding this contract of adoption.

Malan entered into a contract with minor child's mother to provide a father and
mother relationship to raise the minor child. When minor child's mother sought and
received dissolution of the marriage, she broke her contract with Malan to raise said
minor child jointly and in concert.

Wherefore Malan does hereby revoke the signature that he owns off of the
Petition for Adoption filed of record on December 6, 1999 and declares the order

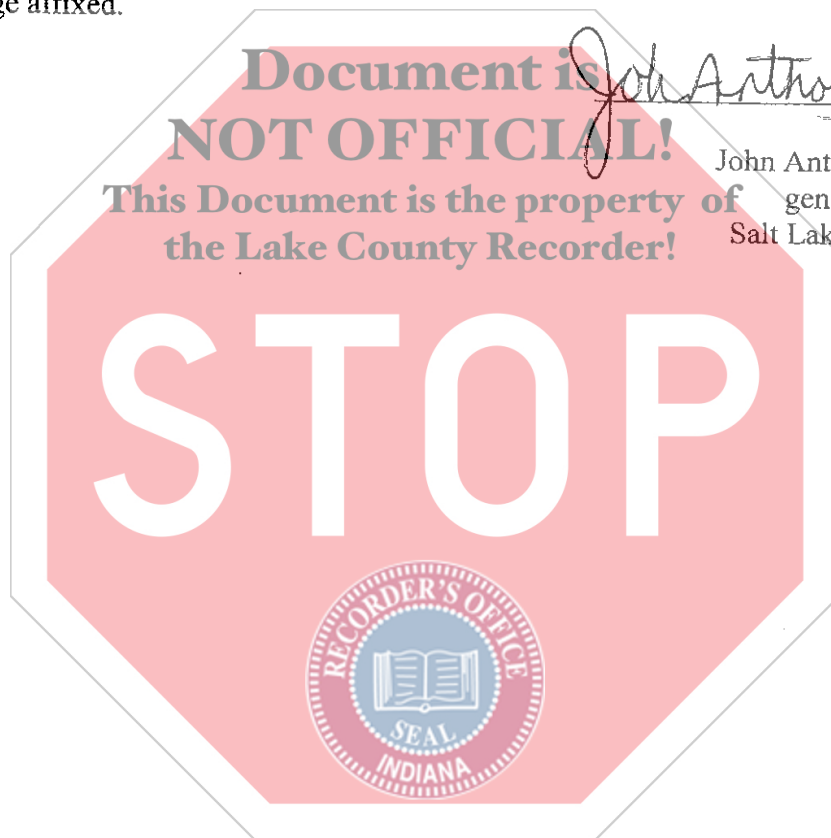
