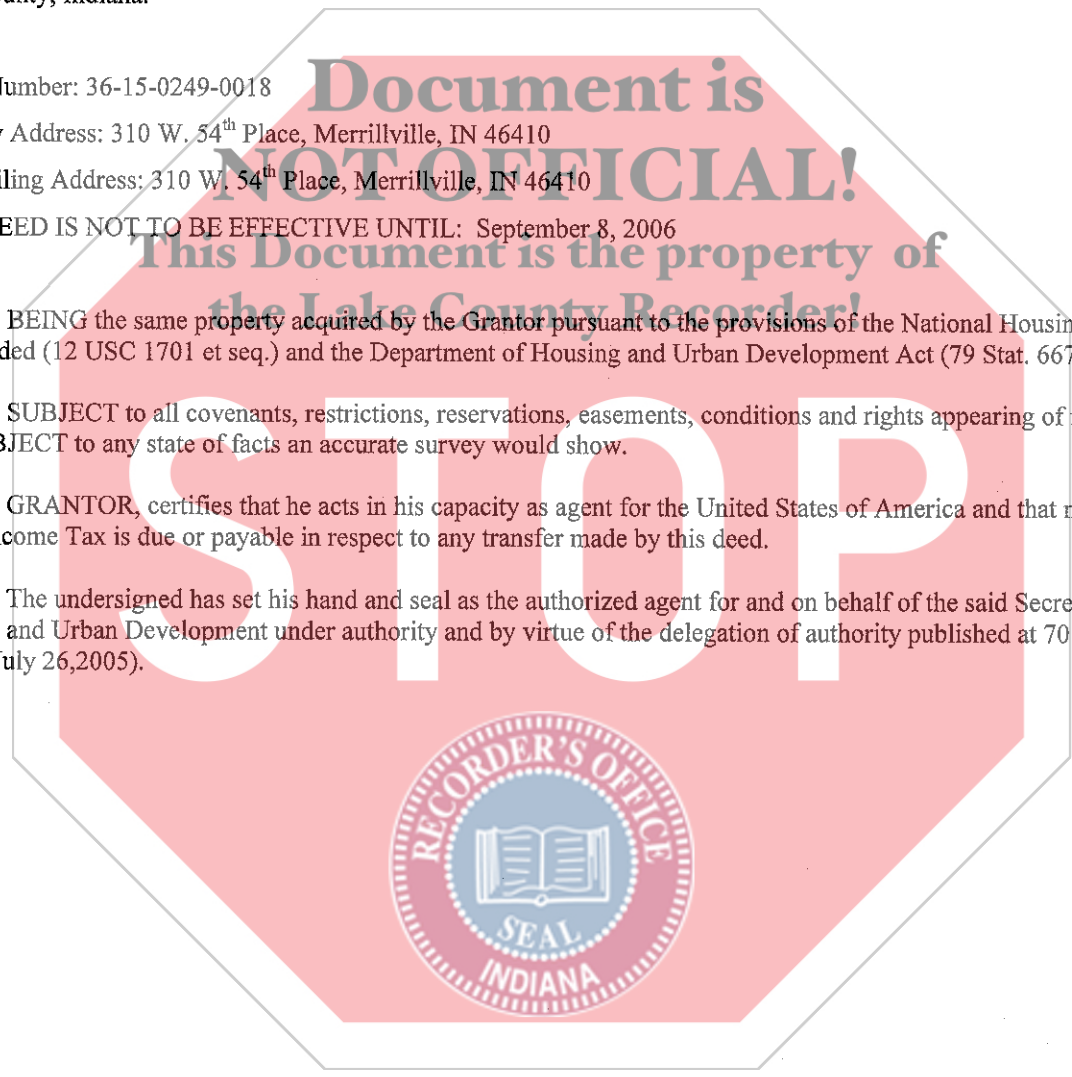
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: September 8, 2006
