any loss accruing up to the effective date of said thirty (30) day cancellation notice, in no event, however, in
excess of the penalty of the bond.

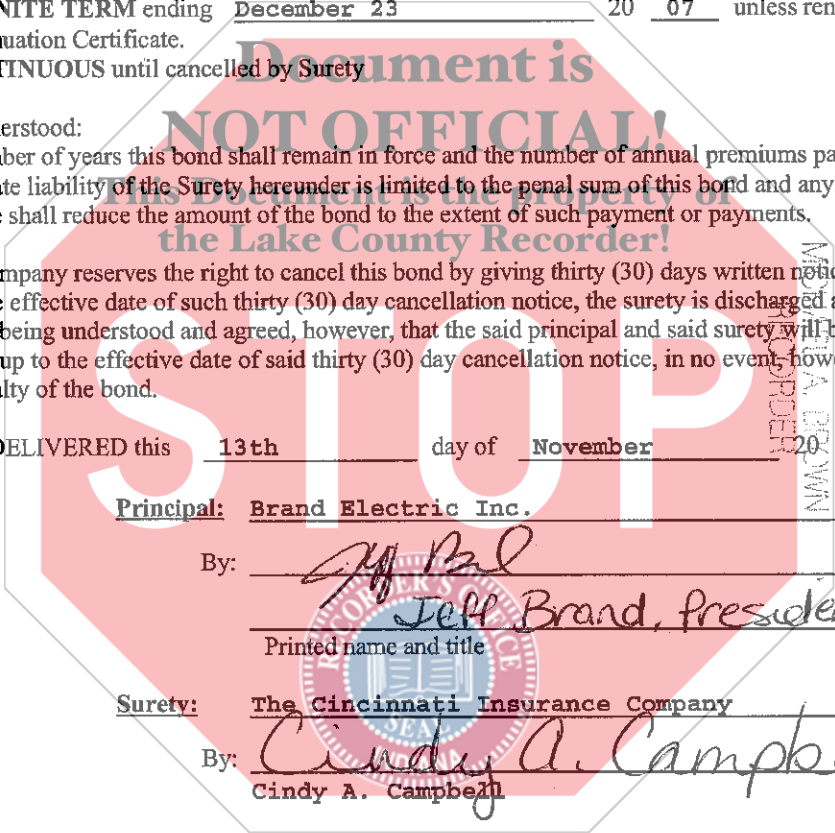
