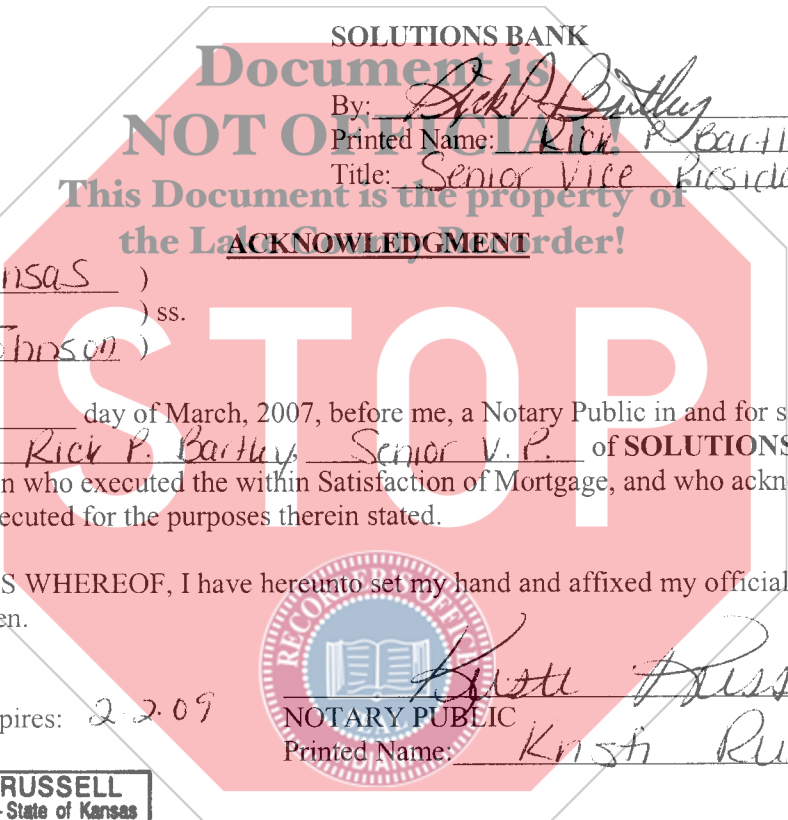

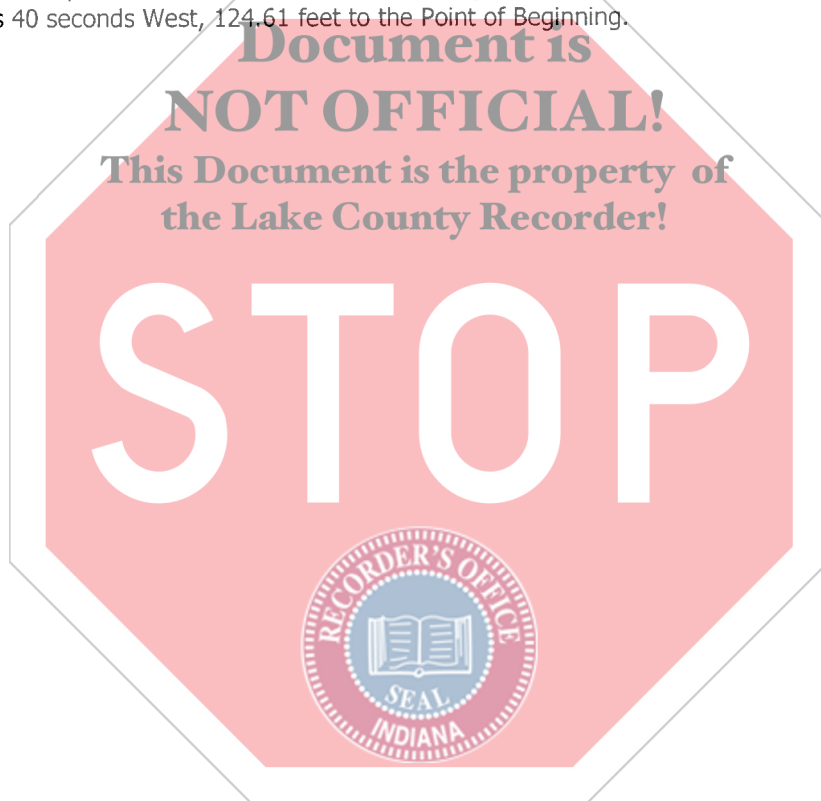

Legal Description: That part of Lot 5, Arie Jabaay's Subdivision of a part of the West Half of Section 13 and a part, of the North Half of Section 24, Township 36 North, Range 10 West of the Second Principal Meridian in the Town of Munster described as commencing at a point on the North line of Ridge Road 160 feet Southeasterly from the West line of said Lot 5, measured along the North line of Ridge Road; thence running southeasterly along the North line of Ridge Road 124.61 feet to the West line Lyman Street; thence North along Lyman Street 107.3 feet; thence Northwesterly parallel with the North line of Ridge Road 124.15 feet; thence South parallel with the West line of said Lot 5, 107.25 feet to the place of beginning, in Lake County, Indiana.
