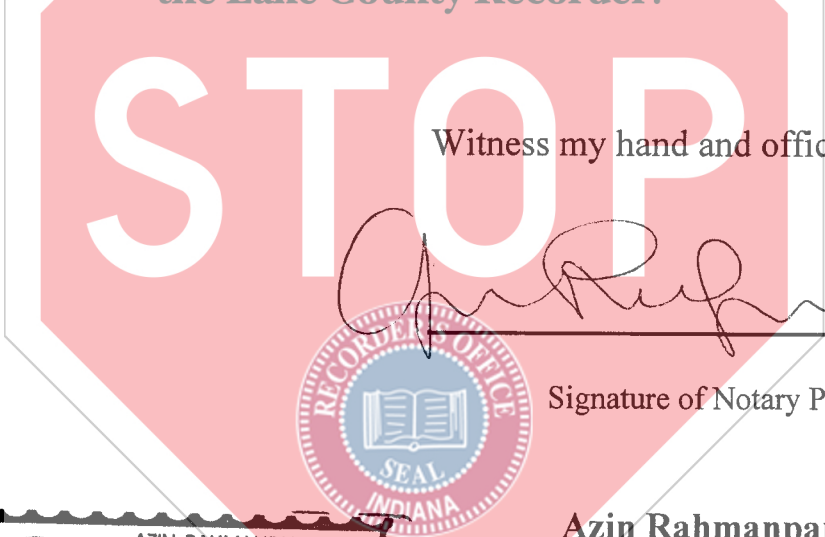


Exhibit A
