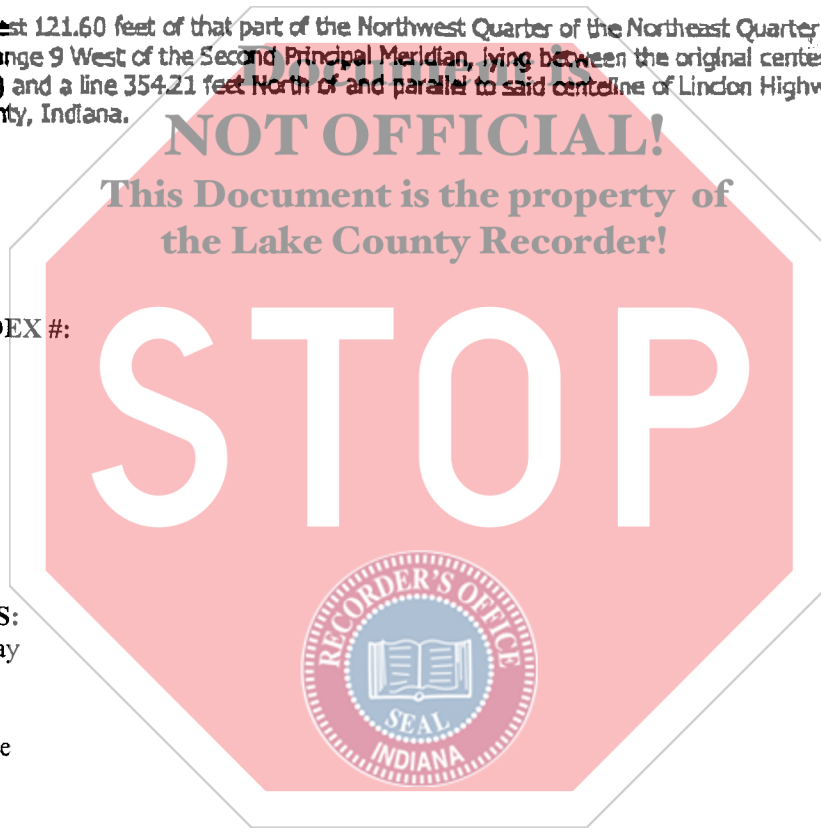
EXHIBIT A
Legal Description

PARCEL ONE: Lots 1 to 6, both inclusive, Block 6, Calumet Boulevard Addition to Hammond, as per plat thereof filed in Plat Book 18, Page 31, in the Office of the Recorder of Lake County, Indiana.

PARCEL TWO: The West 165 feet (except the South 275 feet thereof) of the North 10 acres of the South 20 acres of the West Half of the Southwest Quarter of Section 7, Township 36 North, Range 9 West of the Second Principal Meridian, in Lake County, Indiana, also described as Lot 1, Haak Subdivision, as per plat thereof filed in Plat Book 59, Page 30 in the Office of the Recorder of Lake County, Indiana.

PARCEL THREE: Part of the Northwest Quarter of the Northeast Quarter of Section 17, Township 35 North, Range 9 West of the Second Principal Meridian, Lake County, Indiana, more particularly described as follows: Beginning at a point in the original centerline of Lincoln Highway, which point is 121.60 feet East and 959.98 feet, more or less, South of the Northwest corner of the Northwest Quarter of the Northeast Quarter of said Section 17; thence North and parallel with the West line of the Northeast Quarter of said Section 17 a distance of 354.21 feet; thence Easterly with an interior angle of 84 degrees 29 minutes a distance of 45.41 feet; thence South and parallel with the West line of the Northeast Quarter of said Section 17 a distance of 354.21 feet to the original centerline of Lincoln Highway; thence Westerly with an interior angle of 84 degrees 29 minutes a distance of 45.41 feet to the Point of Beginning, in the Town of Schererville, Indiana.

PARCEL FOUR: The West 121.60 feet of that part of the Northwest Quarter of the Northeast Quarter of Section 17, Township 35 North, Range 9 West of the Second Principal Meridian, lying between the original centerline of Lincoln Highway (now U.S. 30) and a line 354.21 feet North of and parallel to said centerline of Lincoln Highway in the Town of Schererville, Lake County, Indiana.
