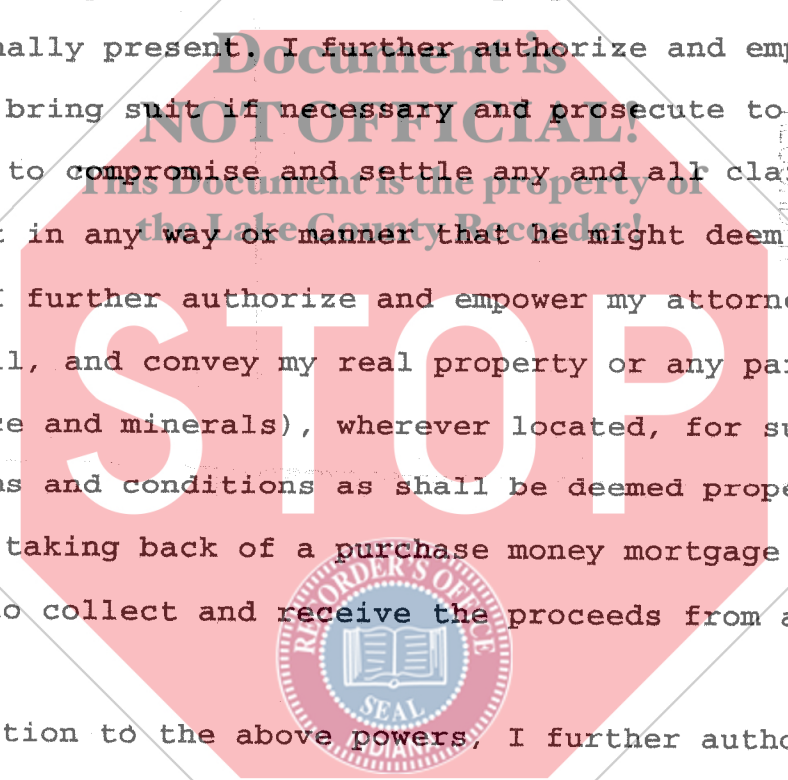
POWER OF ATTORNEY

have in real property, with such persons and on such terms as my attorney shall in his discretion elect; and to execute, acknowledge, and deliver in my name such deeds or conveyances, with such covenants or conditions as he may deem proper, that may be required for the transfer of said property or any part thereof or any interest therein.

My attorney may execute or release mortgages, deeds of trust, or other security agreements as may be necessary to accomplish the purpose of this power of attorney.

My attorney may apply for, endorse, and transfer certificates of title for any motor vehicle.

My attorney may endorse, convey, and otherwise transfer all business interests that I may now own or hereafter acquire.

My attorney may have access to any safe deposit box rented by me and remove the contents of such safe deposit box, and any institution in which a safe deposit box is located shall be relieved of any liability to me, my heirs, or assigns as a result of my attorney's exercise of this power.





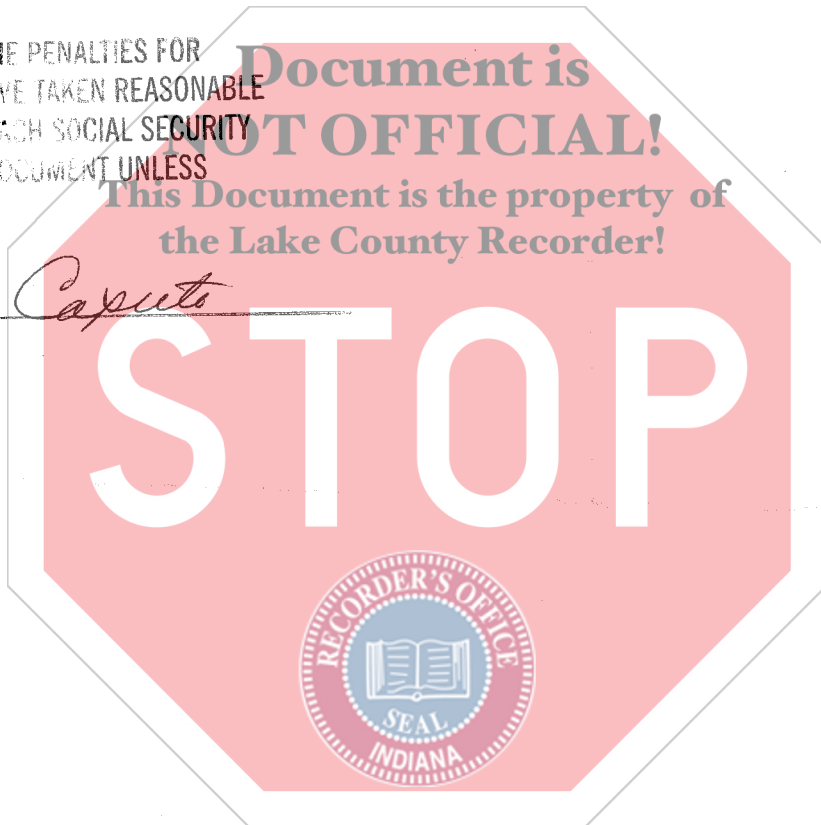
