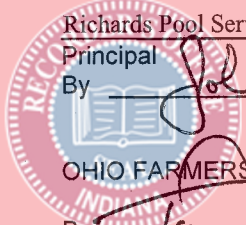
The Condition of this obligation is such, that whereas Principal is desirous of obtaining a license from Town of Winfield to carry on business
