

**LAST WILL AND TESTAMENT OF

I, **FLORENCE MARIE KURELLA**, being of sound and disposing mind and memory not being actuated by any duress, menace, fraud, mistake, or undue influence, do make, publish, and declare this to be my last Will, hereby expressly revoking all Wills and Codicils previously made by me.

I. EXECUTOR: I appoint JOYCE (Botch) PRAMUK as Executor of this my Last Will and Testament and provide if this Executor is unable or unwilling to serve then I appoint ARTHUR RONALD PRAMUK as alternate Executor. My Executor shall be authorized to carry out all provisions of this Will and pay my just debts, obligations and funeral expenses.

II. BEQUESTS: After the payment of all the debts owed in my name, I do hereby give, devise, and bequeath all of the rest, residue, and remainder of my estate, of whatever kind and character, and wherever located to my surviving seven children to whom I gave birth to: Thomas M. If a named beneficiary to this Will predeceases me, the bequest to such person shall lapse, and the property shall pass under the other provisions of this Will. If I do not possess or own any property on the date of my death, the bequest of that property shall lapse.

III. SIMULTANEOUS DEATH OF BENEFICIARY: If any beneficiary of this WILL shall die prior to me or prior to the distribution of my estate, their share will go to their surviving children, MY Grandchildren.

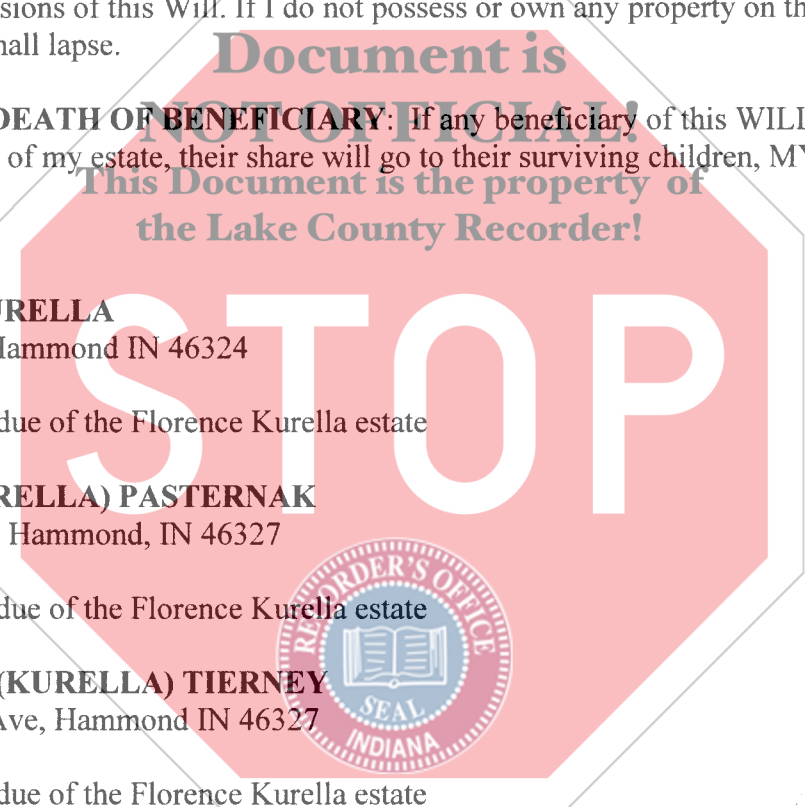

Any and all debts of my estate shall first be paid from my residuary estate. Any debts on any real property bequeathed in this Will shall be assumed by the person to receive such real property and not paid by my Executor.

Most of my household goods and belongings have already been disposed of, or promised to someone. The remainder of my personal effects can be divided between whom ever wants them.

I desire to have a funeral service held at Baran & Son's Funeral Home, 1235 119th St, Whiting Indiana 46394 Funeral service as close to the one my husband ALBERT W. KURELLA had, has been pre-arranged. I also desire to be buried in the St. John Diocesan Catholic Cemetery, 1547 167th St, Hammond Indiana Next to my husband in the family plot.

VIII. CONSTRUCTION: The term "testator" as used in this Will is deemed to include me as Testator or Testatrix. The pronouns used in this Will shall include, where appropriate, either gender or both, singular and plural.

IX. SEVERABILITY AND SURVIVAL: If any part of this Will is declared invalid, illegal, or inoperative for any reason, it is my intent that the remaining parts shall be effective and fully operative, and that any Court so interpreting this Will and any provision in it construe in favor of survival.
