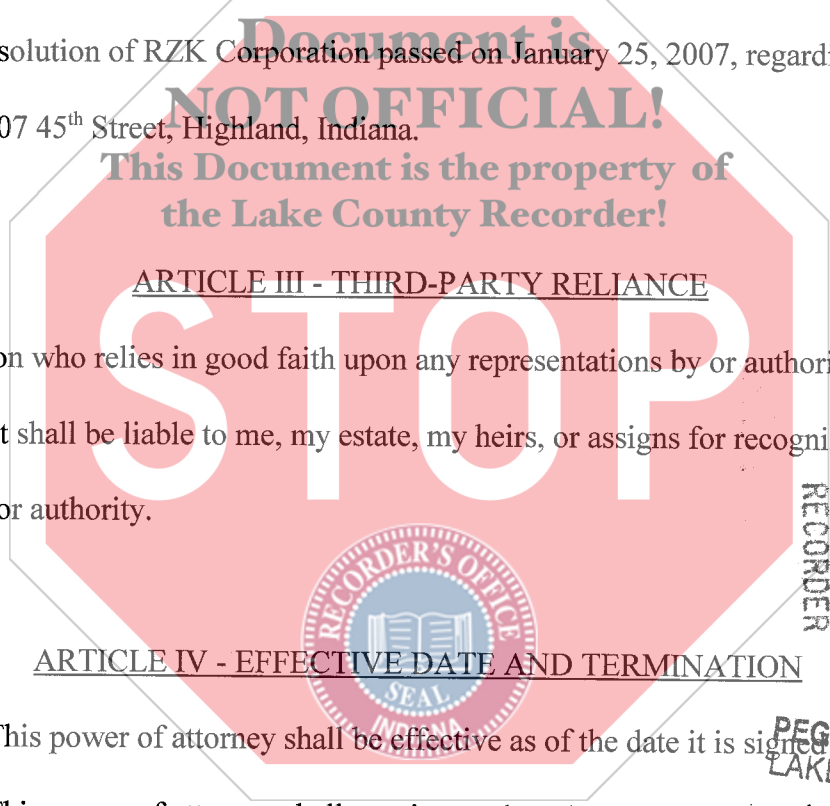
**ARTICLE I - DESIGNATION OF AGENT**
