Subject to all covenants, conditions, easements, agreements, limitations, and restrictions of record

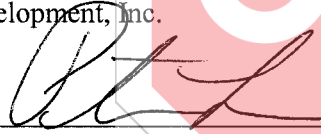
Subject to real estate taxes for 2006 payable in 2007 together with delinquency and penalty if any, and all real estate taxes due and payable thereafter.

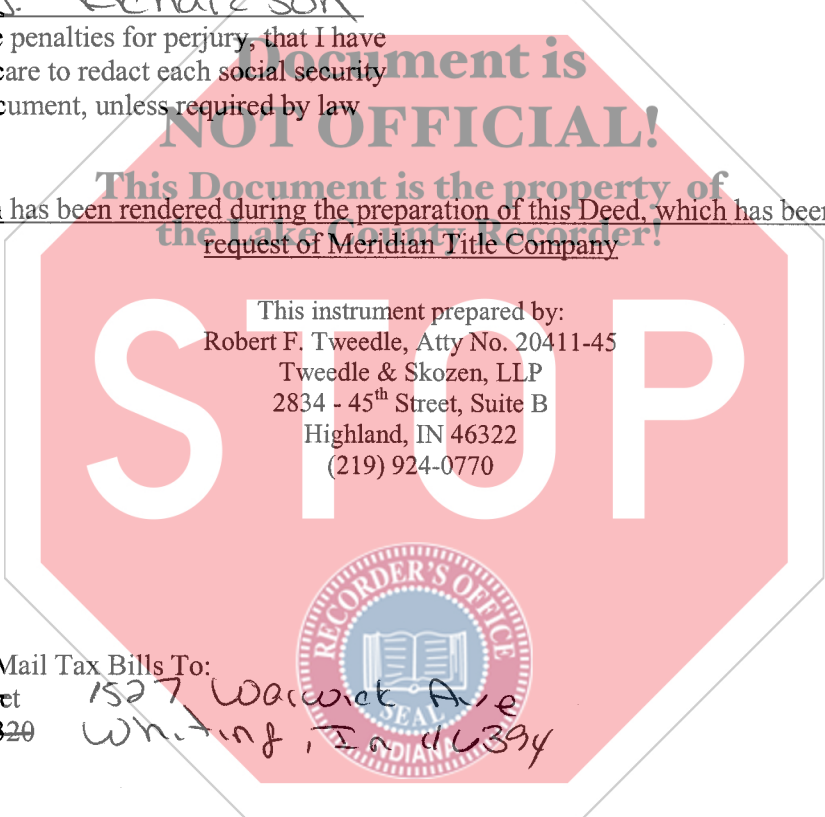
