done.

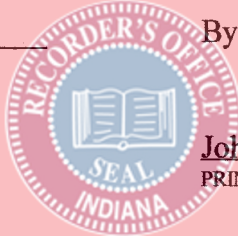

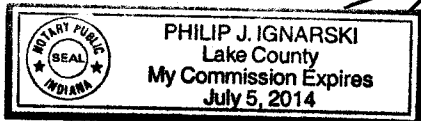
