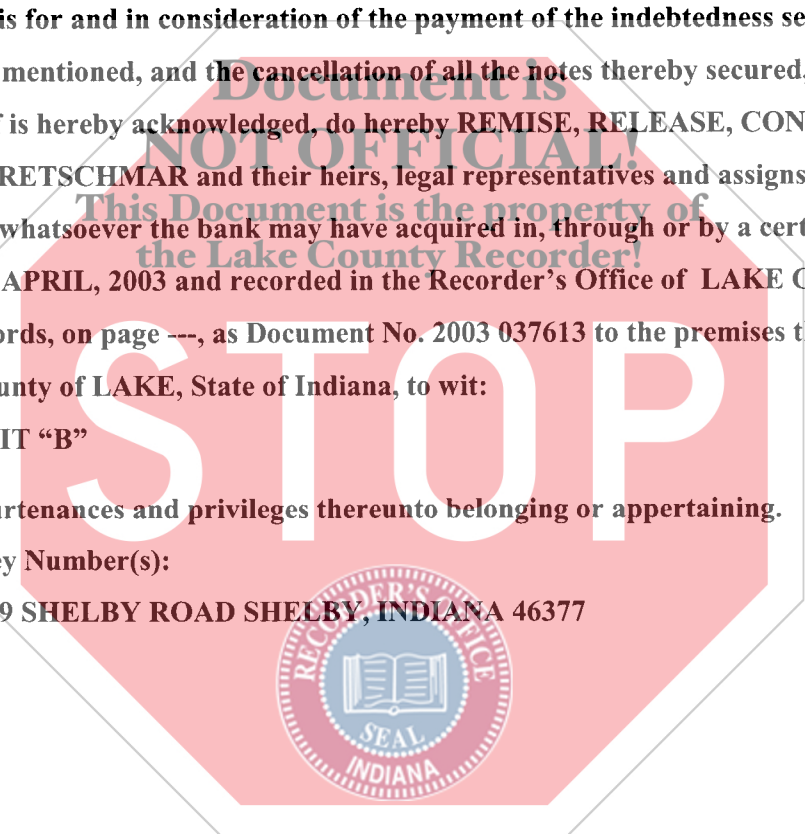

EXHIBIT "B"

Legal Description

That part of the Northeast 1/4 of Section 33, Township 32 North, Range 8 West of the 2nd Principal Meridian, in Lake County, Indiana, more particularly described as follows: Commencing at the Northwest corner of said Northeast 1/4 and running thence South along the West line thereof, 1180 feet, thence East parallel with the North line thereof 266.92 feet to a point in the Westerly line of State Road No. 55; thence South 24 degrees 12 minutes East along said Westerly line, 252.12 feet; thence West parallel with the North line of the Northeast 1/4 of said section, 178.11 feet; thence South 24 degrees 12 minutes East, 408.17 feet; thence East parallel with the North line of said Northeast 1/4, 28.11 feet to the place of beginning; thence Southeasterly 130.92 feet, more or less, to a point on the North bank of the Marble-Powers Ditch which is 157.5 feet Westerly measured along said North Bank from its intersection with the Westerly line of State Road No. 55; thence Easterly along said bank 157.5 feet to the Westerly line of State Road No. 55; thence North 4 degrees 35 minutes West along said Westerly line of State Road No. 55, a distance of 28.81 feet; thence continuing North 24 degrees 12 minutes West along said Westerly line to a point due East of the Place of beginning; thence due West to the place of beginning, excepting therefrom that part deeded to the State of Indiana by Warranty Deed recorded June 24, 1991 as Document No. 91031118.
