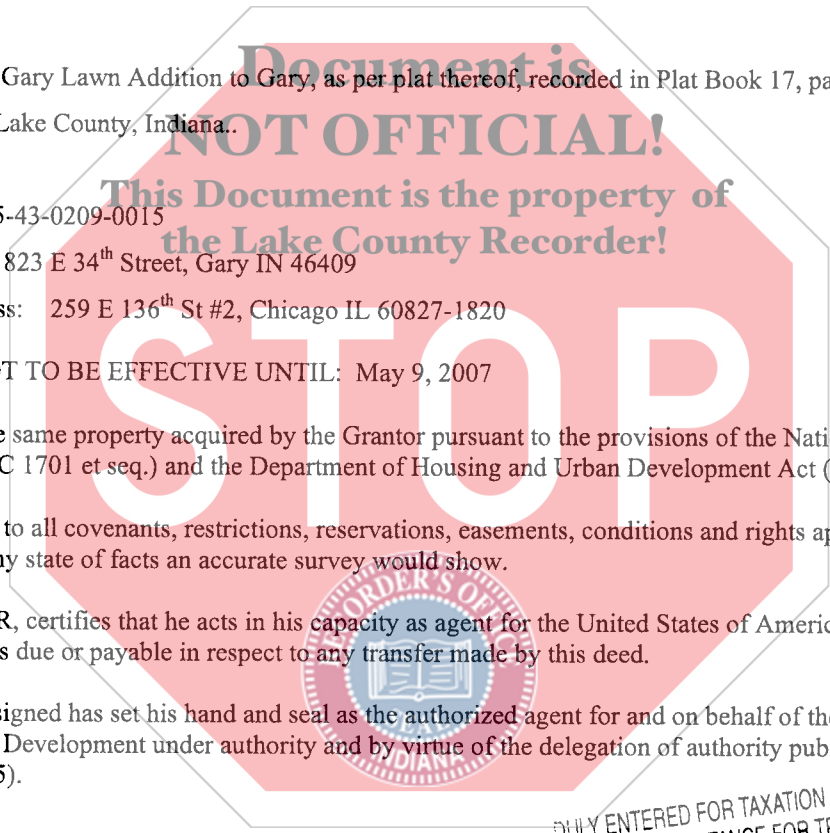
THIS DEED IS NOT TO BE EFFECTIVE UNTIL: May 9, 2007
