PLUMBING LIC. CONTRACTORS BOND

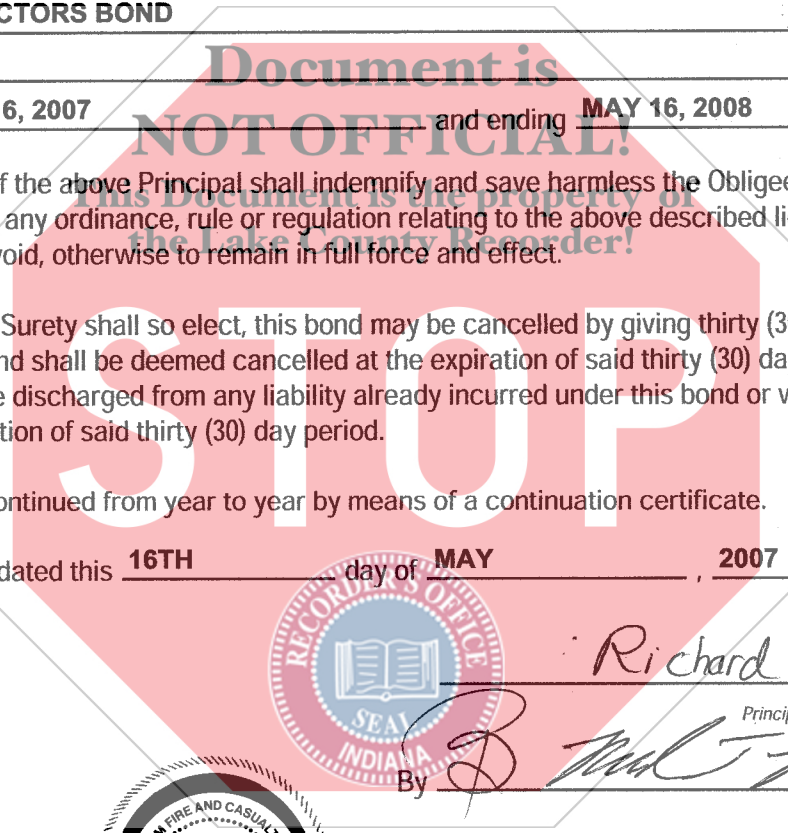
for a term beginning MAY 16, 2007 and ending MAY 16, 2008

POWER OF ATTORNEY
