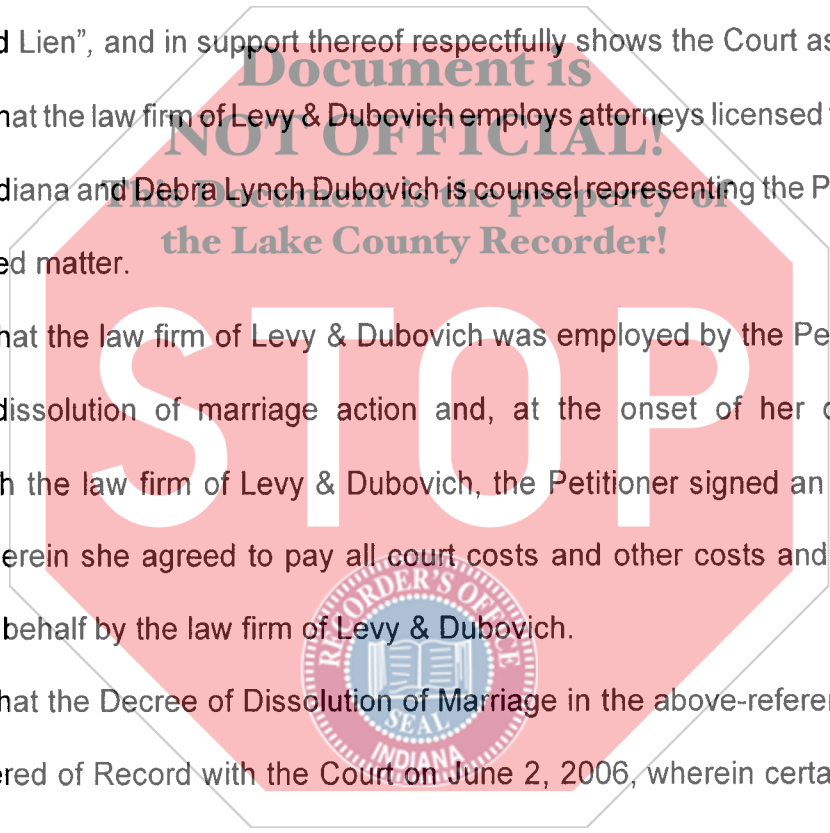

**NOTICE OF INTENTION TO HOLD LIEN**

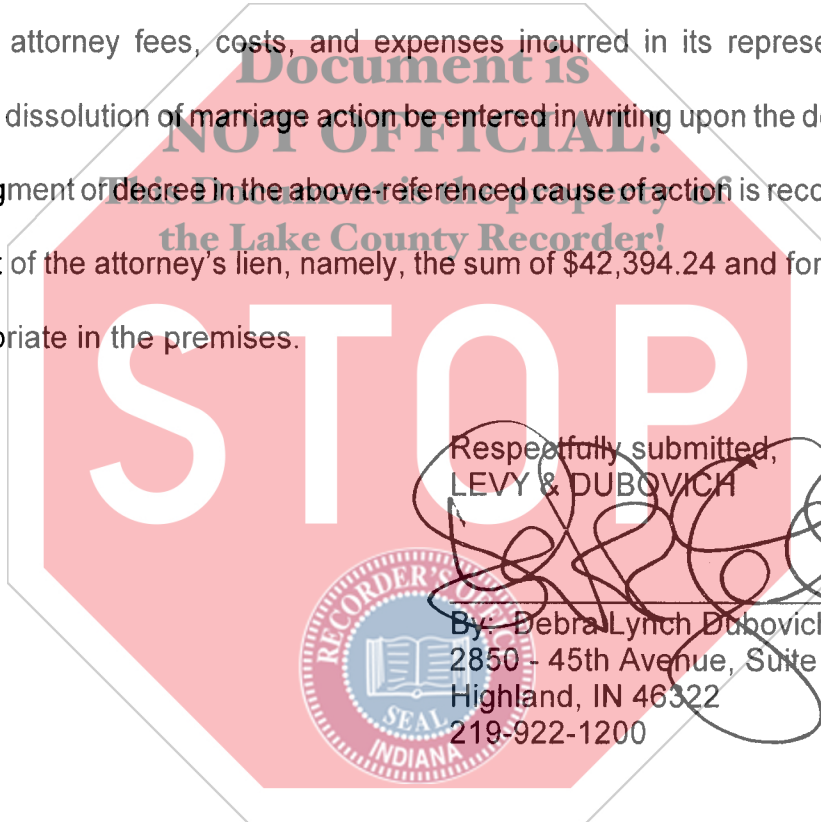


