**Legal Description:** The West 10 acres of the East ½ of the NW ¼ of Section 35, Township 36 North, Range 8 West of the 2<sup>nd</sup> Principal Meridian, less and except the following legal description as shown in Right of way Grant to the State of Indiana, as shown in Right of Way Book 1229, page 421. More particularly described as follows:

A part of the East half of the Northwest Quarter of Section 35, Township 36 North, Range 8 West, Lake County, Indiana, described as follows: Beginning at the Northeast corner of the West 10 acres of said half Quarter Section, said point being North 89 degrees 38 minutes 30 seconds West 1,150.50 feet from the Northeast corner of said Quarter Section (along the North line of said Quarter Section); thence South 0 degrees 22 minutes 30 seconds East 949.37 feet along the East line of the West 10 acres of said Half Quarter Section; thence South 20 degrees 00 minutes 45 seconds West 17.31 feet; thence South 20 degrees 08 minutes 30 seconds West 454.84 feet to the West line of said Half Quarter Section; thence North 0 degrees 21 minutes 12 seconds West 666.74 feet along said West line; thence Northeasterly 675.06 feet along an arc to the left and having a radius of 4,182,18 feet and subtended by a long shord having a bearing of North 13 degrees 11 minutes 31 seconds East and a length of 674.33 feet; thence North 3 degrees 01 minutes 41 seconds East 69.49 feet to the North line of said Half Quarter Section; thence South 89 degrees 38 minutes 30 seconds East 2.89 feet along said North line to the point of beginning, and less and except the following: The South ½ of the West ten acres of the East ½ of the NW ¼ of Section 35, Township36 North Range 8 West of the 2nd P.M., as shown in Instrument No. 171177.
