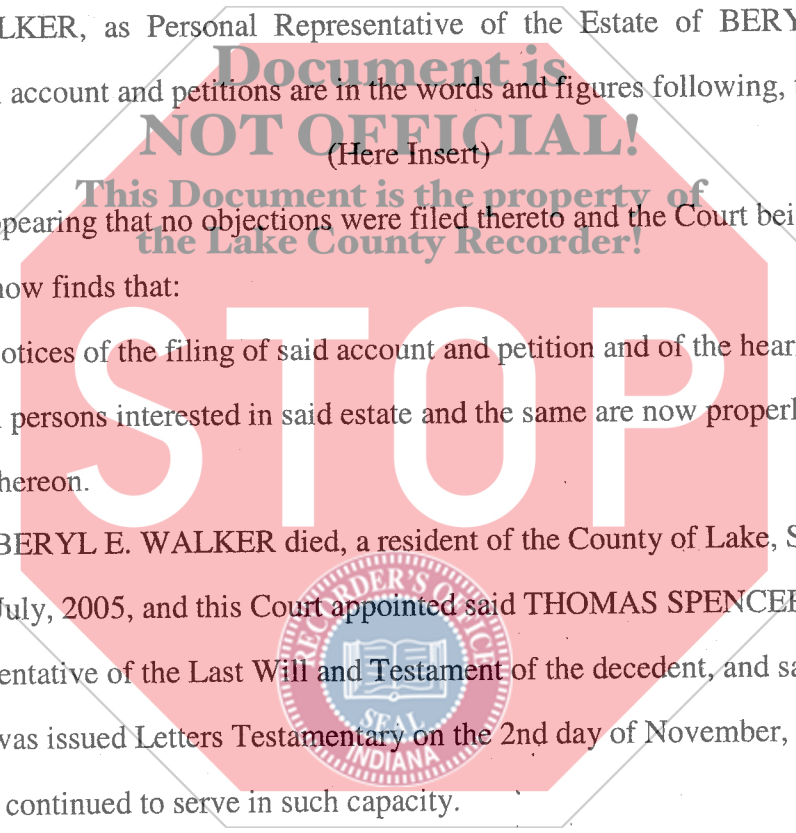

3. That the matters and things stated in said accounting and petition are true, and the Personal Representative administered no funds belonging to the decedent and accordingly no financial accounting needs to be made in this case.

4. That more than three (3) months have elapsed since the date of the first published notice to the legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Personal Representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; and all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

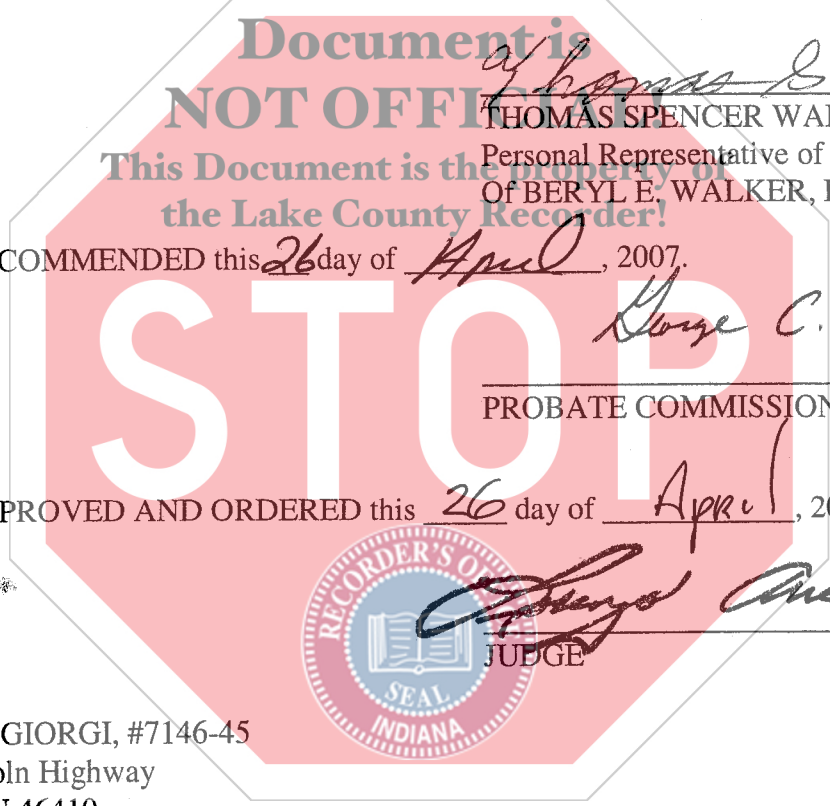
