The undersigned being first duly sworn upon his oath states:

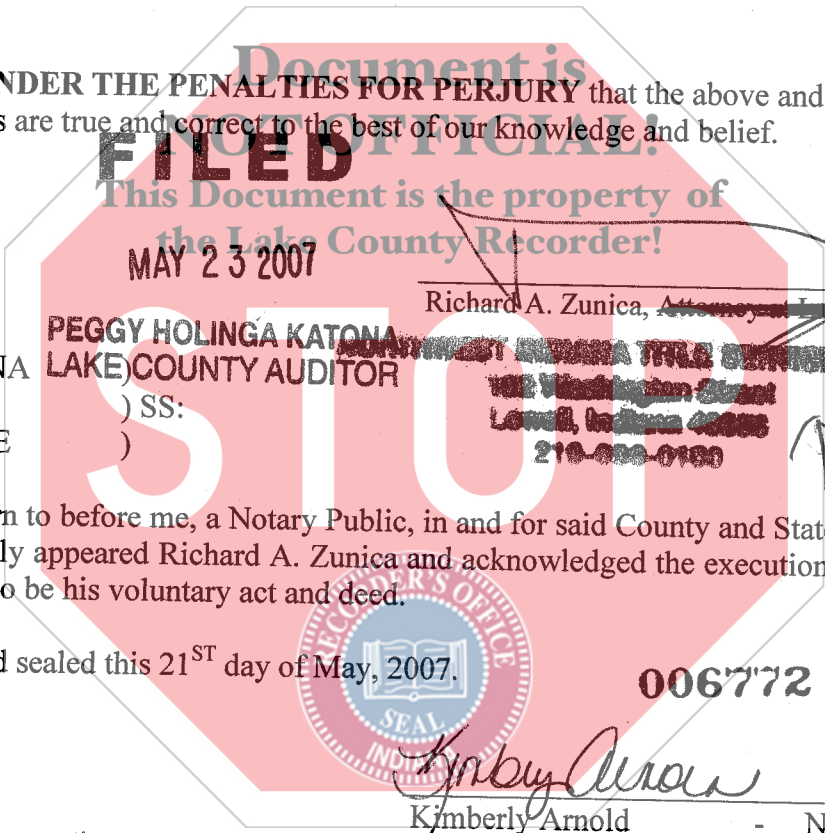
1. That Clarence J. Schafer and Augusta Schafer were the owners of the following described property located in Lake County, Indiana:

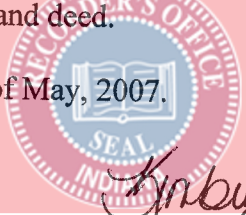
