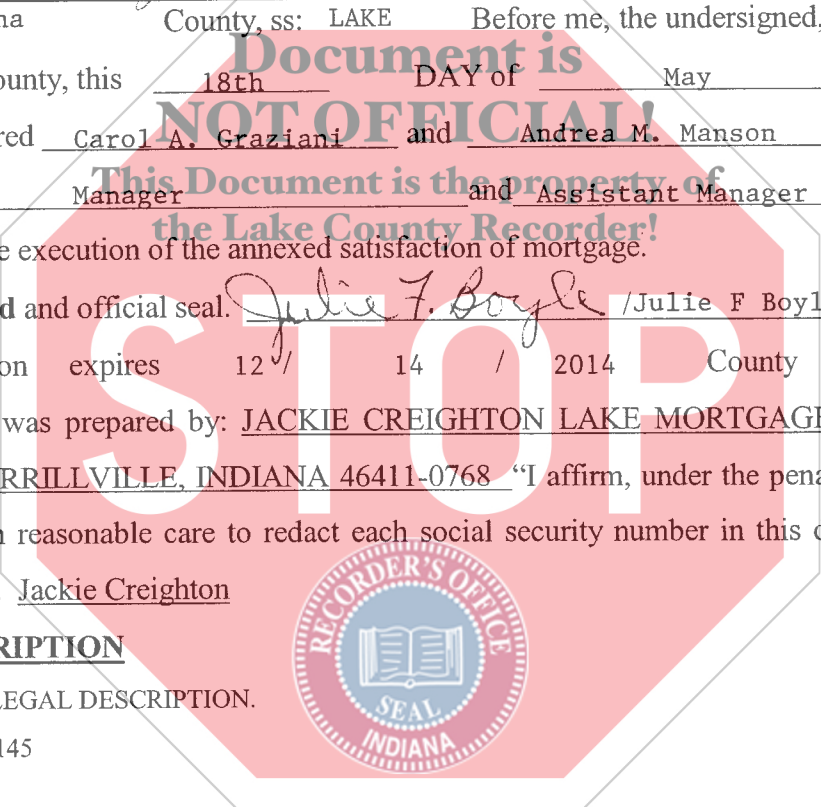

LEGAL DESCRIPTION

Part of the West 1/2 of the Northeast 1/4 of Section 29, Township 35 North, Range 9 West of the 2nd Principal Meridian, in the Town of St. John, Lake County, Indiana, more particularly described as follows: Beginning at a point in the center line of a public highway known as The Chicago Road, said point being 896.25 feet, measured along said center line, North of the South line of the North 1/2 of the South 1/2 of said West 1/2 of the Northeast 1/4; thence East, parallel with said South line of the North 1/2 of the South 1/2 of the West 1/2 of the Northeast 1/4 a distance of 499.83 feet to the Southwesterly right of way line of the Chicago, Indianapolis and Louisville (Monon) Railroad; thence Northwesterly on said Southwesterly right of way line, 549.21 feet to the center line of an 18 foot private lane; thence Southwesterly, along said center line, 360.05 feet to the center line of the Chicago Road; thence Southerly on said center line 125.0 feet to the point of beginning.
