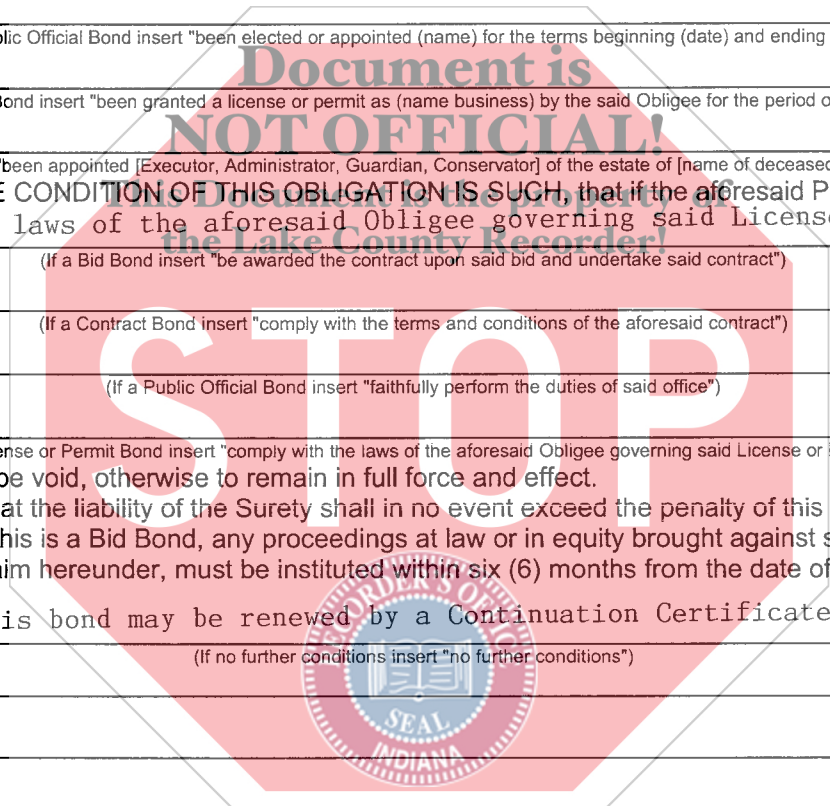
Then this obligation shall be void, otherwise to remain in full force and effect.

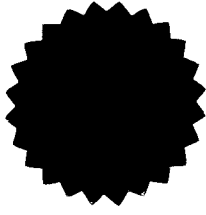

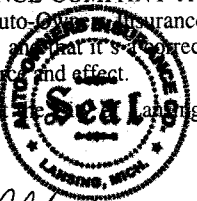
