TRUSTEE'S DEED

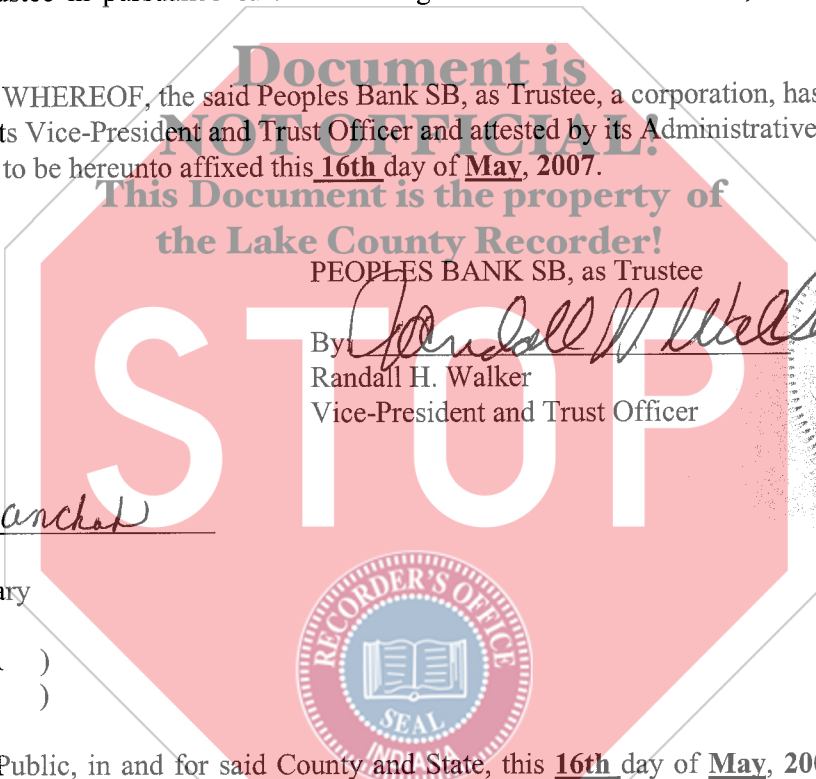

- 2. All covenants, easements, assessments and restrictions now of record.

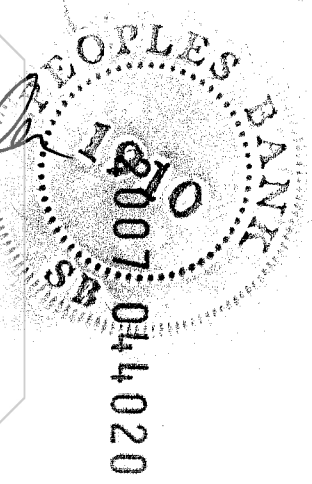

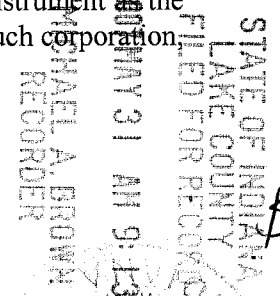
