IN WITNESS WHEREOF, The said Trustee has caused this deed to be executed by and through its Trust Officer this 16th day of May, 2007.

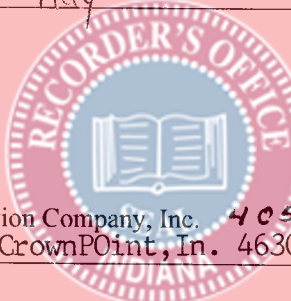
