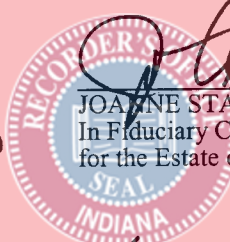
PERSONAL REPRESENTATIVES' DEED
