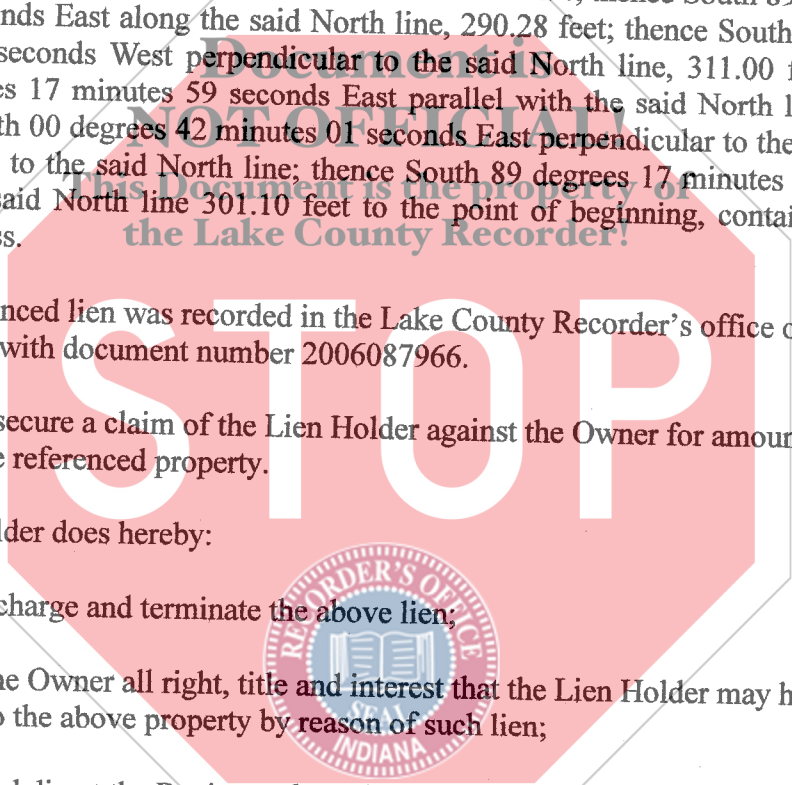
The a LEGAL DESCRIPTION: A part of the Northeast 1/4 of Section 19, Township 35 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana, described as follows: Beginning at the Northeast corner of said Section 19; thence South 00 degrees 45 minute 18 seconds East along the East line of said Northeast 1/4, 2310.68 feet to the North right-of-way line of the Louisville, New Albany, and Chicago Railroad (now the Chicago, Indianapolis and Louisville Railway); thence North 45 degrees 25 minute 51 seconds West along the said North right-of-way line of the Louisville, New Albany, and Chicago Railroad (now the Chicago, Indianapolis and Louisville Railway), 1238.95 feet to a point; thence North 00 degrees 45 minutes 18 seconds West parallel with the said East line, 1451.80 feet to the North line of said Northeast 1/4; thence South 89 degrees 17 minutes 59 seconds East along the said North line, 290.28 feet; thence South 00 degrees 42 minutes 01 seconds West perpendicular to the said North line, 311.00 feet; thence South 89 degrees 17 minutes 59 seconds East parallel with the said North line, 280.00 feet; thence North 00 degrees 42 minutes 01 seconds East perpendicular to the said North line, 311.00 feet to the said North line; thence South 89 degrees 17 minutes 59 seconds East along the said North line 301.10 feet to the point of beginning, containing 35.37 acres more or less.

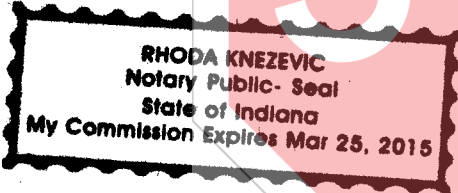
