SPECIAL WARRANTY DEED

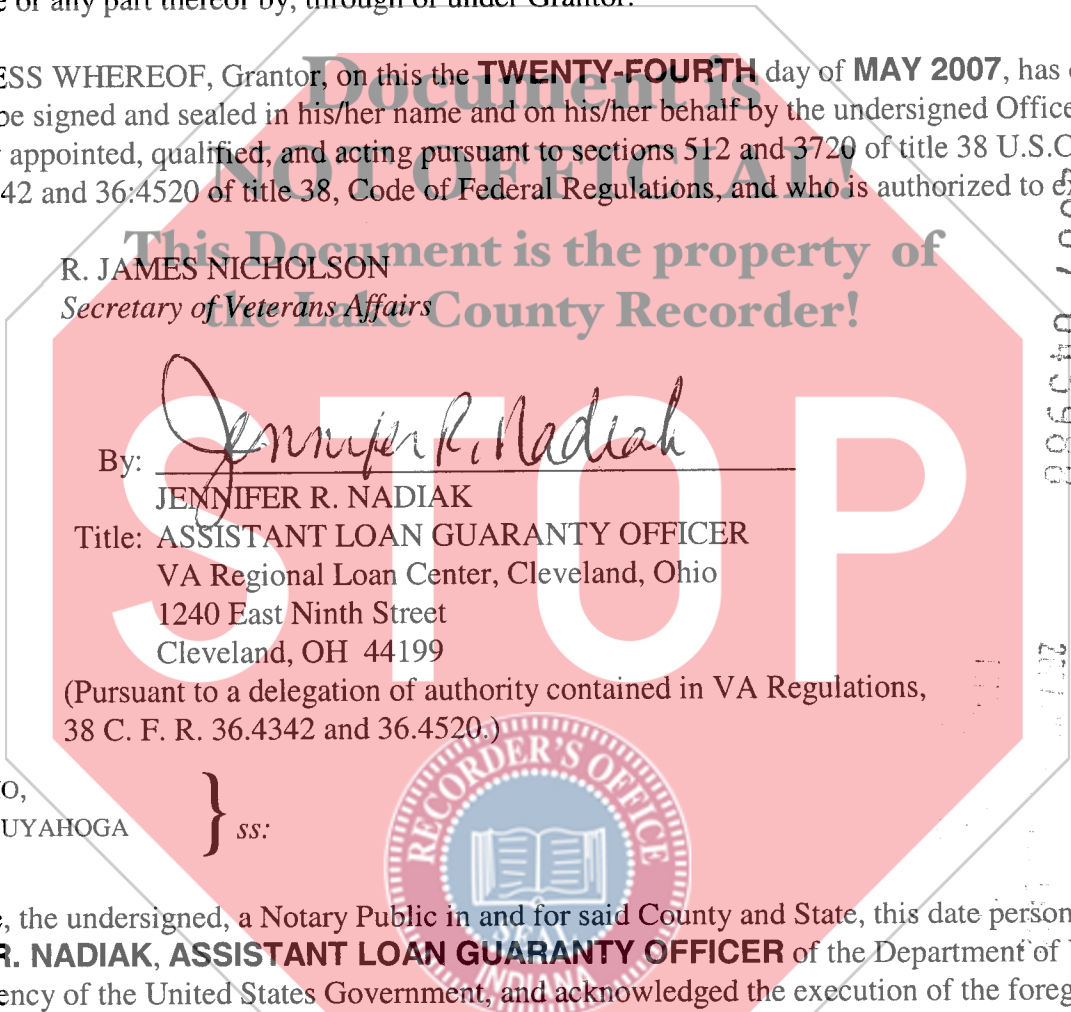
