4. This Affidavit has been made and executed in order to correct the scrivener's errors.

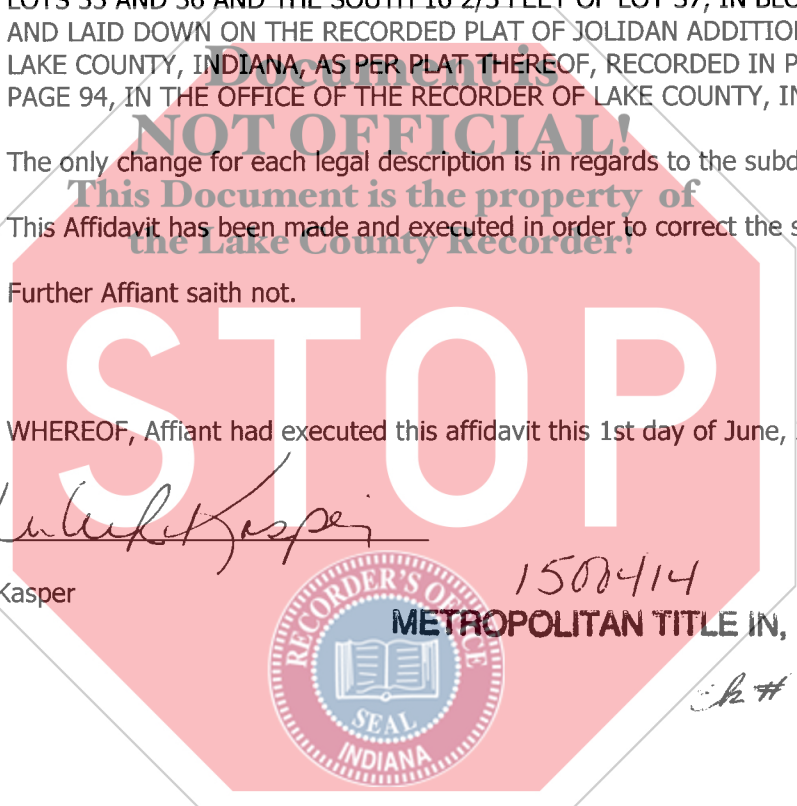
