described real estate in Lake County, State of Indiana:

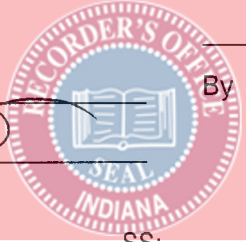
That part of Lot 50 in Madison Meadows, Phase Two, an Addition to the Town of Merrillville, Indiana, as per plat

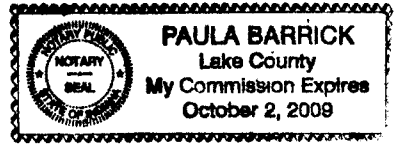
