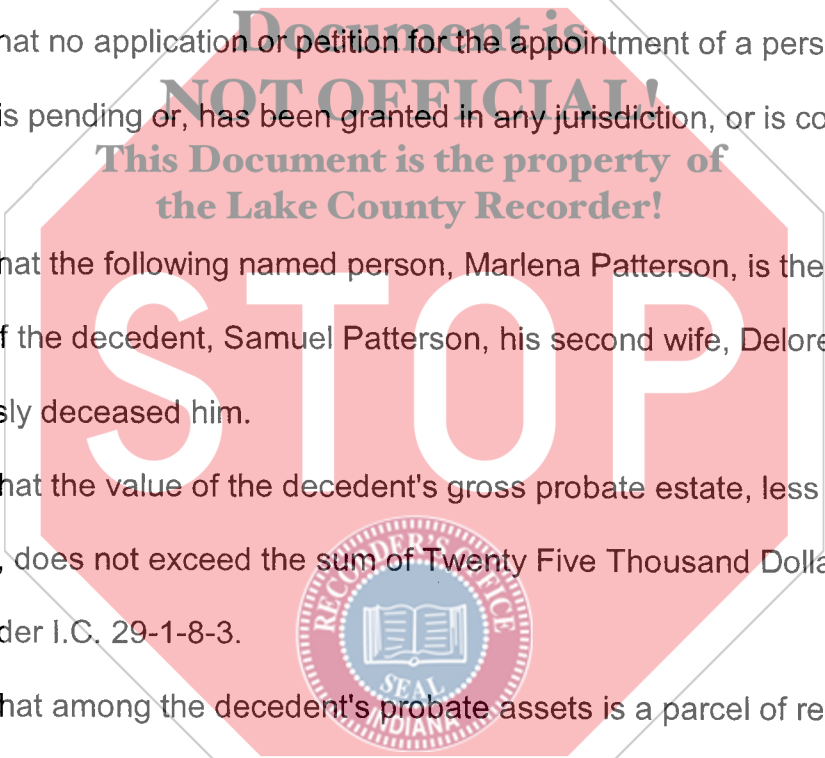

AFFIDAVIT FOR TRANSFER OF REAL PROPERTY

That the Affiant being first duly sworn upon her oath, deposes and states as follows:
