SHERIFF'S DEED

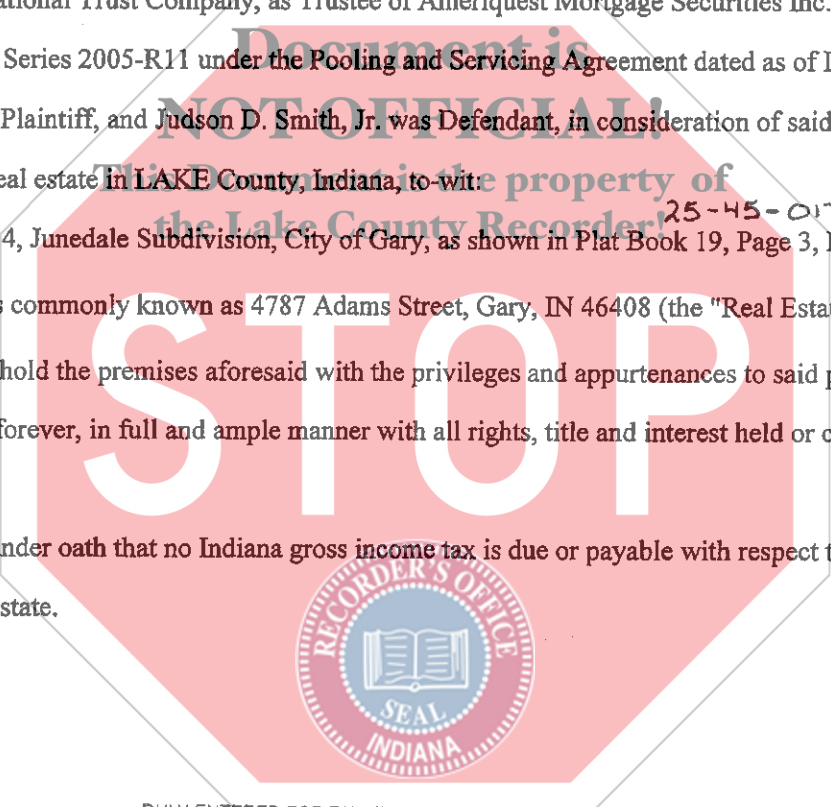
