City of Gary, State of Indiana:

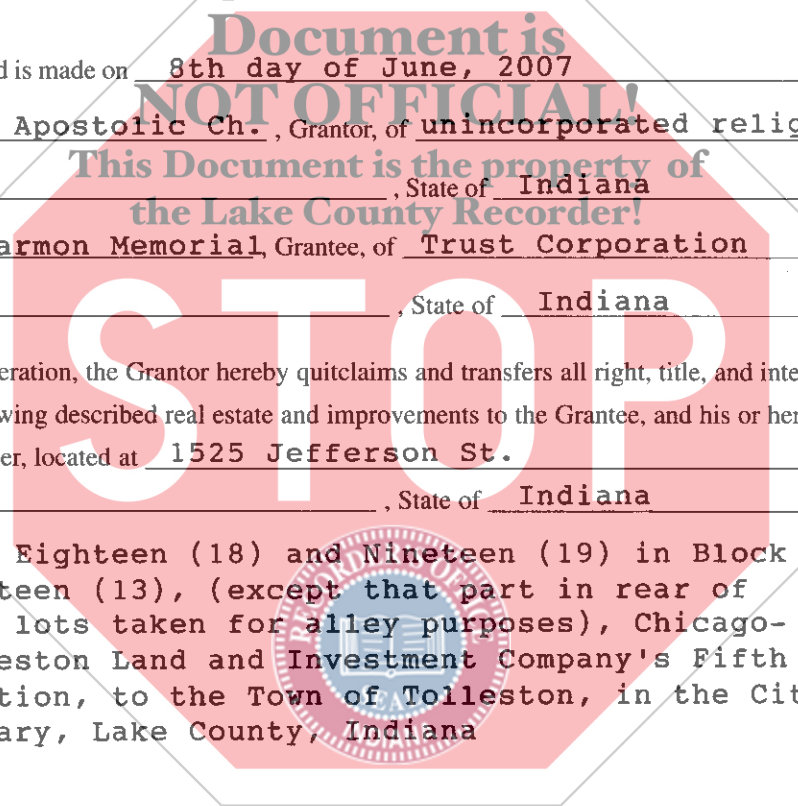
